THE PICKLED SHEEP AND LAMB PELT EMERGENCY REGULATIONS 1947. AMENDMENT NO. 1

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Emergency Regulations Continuance Act, 1947, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Pickled Sheep and Lamb Pelt Emergency Regulations 1947, Amendment No. 1, and shall be read together with and deemed part of the Pickled Sheep and Lamb Pelt Emergency Regulations 1947* (hereinafter referred to as the principal regulations).
- 2. Regulation 2 of the principal regulations is hereby amended by omitting from the definition of the term "Pelts" the words "1st day of October, 1947", and substituting the words "1st day of October, 1948".
- 3. Regulation 5 of the principal regulations is hereby amended by omitting from subclause (1) the words "1st day of October, 1947", and substituting the words "1st day of October, 1948".
 - 4. Regulation 8 of the principal regulations is hereby revoked.
- 5. Regulation 9 of the principal regulations is hereby amended by omitting from subclause (1) the words "under Regulation 8 hereof, or".

- 6. Regulation 11 of the principal regulations is hereby amended by revoking subclause (3), and substituting the following new subclauses:—
- "(3) The Controller may from time to time fix reserve prices for the purposes of any auction sale held under these regulations.
- "(4) If a reserve price is not reached at any sale the pelts then offered for sale shall be deemed to have been purchased at the auction by the Minister on behalf of the Government of New Zealand at a price equal to the appropriate amounts indicated in the second or third column of the Second Schedule hereto with reference to the works at which the pelts were produced or, if the pelts were the product of stock killed at any other freezing-works indicated in the first column of the said Schedule, to the appropriate amount indicated in the second or third column with reference to that freezing-works.
- "(5) Any pelts so purchased by the Minister may at any time thereafter be resold by the Controller as agent for the Government of New Zealand at such price, in such manner, and upon such conditions as he thinks fit."
- 7. Regulation 13 of the principal regulations is hereby amended by omitting from subclause (1) the words "whether at auction or by private contract,".
- 8. Regulation 14 of the principal regulations is hereby amended as follows:—
 - (a) By inserting in subclause (1), after the words "for all pelts sold", the words "to a purchaser other than the Minister":
 - (b) By inserting in subclause (3), after the word "purchase-price", the words "for pelts sold to a purchaser other than the Minister":
 - (c) By adding the following new subclause:—
 - "(4) The purchase-price for pelts sold to the Minister and any extra cost payable to the vendor under subclause (1) of Regulation 13 hereof shall be paid out of the Meat Industry Stabilization Account. The whole amount realized on the resale of any pelts under subclause (5) of Regulation 11 hereof shall be paid to the Marketing Department for the credit of that account."
- 9. Regulation 15 of the principal regulations is hereby amended by adding to subclause (1) the following words: "and shall, not later than the 15th day of February, 1948, advise the Controller of their requirements of pickled pelts produced from sheep and lambs killed during the season which commenced on the 1st day of October, 1947".
- 10. Regulation 21 of the principal regulations is hereby amended by adding the following as subclause (3) thereof:—
- "(3) Each tanner to whom any skins are delivered by a freezing company or meat-exporter pursuant to this regulation shall pay such price therefor to the freezing company or meat-exporter as may be determined by the Controller, being such price as the Controller determines to be equivalent to the current market value of wool on the skins, together with the value of the pelt content thereof which shall be based on the ceiling prices for pelts which were ruling on the 30th day of June, 1946."

11. The principal regulations are hereby amended by revoking the Second Schedule, and substituting the following Schedule:—
