THE PUBLIC SERVICE AMENDING REGULATIONS, 1936, AMENDMENT NO. 2.

Enacting authority: The Public Service Commissioners with the approval of the Governor-General in Council.

Acts pursuant to which the regulations were made : The Public Service Act, 1912, and section 41 of the Finance Act, 1936.

Date on which the regulations were made : 11th day of December, 1936.

Date of approval by the Governor-General in Council: 23rd day of December, 1936.

Date of notification in Gazette: 8th day of January, 1937.

REGULATIONS.

1. These regulations may be cited as the Public Service Amending Regulations, 1936 (Amendment No. 2).*

2. These regulations shall be read together with and form part of the regulations made under the Public Service Act, 1912, on the 31st day of March, 1913, and published in the *Gazette* on the 1st day of April, 1913 (hereinafter called "the principal regulations").

3. These regulations shall come into force on the day following notification in the *Gazette* of the making hereof.

4. Regulation 8D of the principal regulations is hereby amended by revoking the words "forty-four hours", and substituting therefor the words "forty hours".

5. Regulation 49 of the principal regulations is revoked, and the following substituted :--

LEAVE OF ABSENCE FOR RECREATION.

49. Every officer in the Public Service and every temporary employee, if circumstances should arise necessitating the retention of such employee in the Service for more than a year, may be granted by the Permanent Head leave of absence for recreation on the following scale :—

- (a) When an officer has served for ten years or upwards, not exceeding three weeks in each year.
- (b) When an officer has served less than ten years, not exceeding two weeks in each year.
- (c) Officers who generally work more than six days a week, not exceeding four weeks in each year, to be taken in two periods of two weeks each if desired.

Public Service Amending Regulations, 1936, Amendment No. 2.

For the purpose of this regulation the term "week" is deemed to mean five working-days in the case of an officer usually working five days each week and in the case of an officer usually working six days each week it is deemed to mean six working-days. The granting of any such leave of absence shall be subject to the express conditions—

- (i) That the behaviour of the officer has been in every way satisfactory; and
- (ii) That his official duties have been satisfactorily performed.

Where an officer has been absent on sick or special leave, whether with or without pay, exceeding thirty days in one or more periods in any leave year, the period of annual leave shall be reduced by one day for every thirty days (including Saturdays and Sundays) of such absence. In special cases the Commissioners may grant further leave.

6. Regulation 51 of the principal regulations is hereby amended by revoking the words "thirty-six working-days", and inserting the words "six weeks".

These regulations are administered by the Office of the Public Service Commissioners.
