

THE PUBLIC SERVICE AMENDING REGULATIONS 1939 (NO. 3).

IN pursuance and exercise of the authority conferred on him by the Public Service Act, 1912, the Public Service Commissioner doth, subject to the approval of the Governor-General in Council, hereby make the following regulations.

REGULATIONS.

1. These regulations may be cited as the Public Service Amending Regulations 1939 (No. 3).

2. These regulations shall be read together with and form part of the regulations made under the Public Service Act, 1912, on the 31st day of March, 1913* (hereinafter called the principal regulations).

3. These regulations shall come into force on the day following notifications in the *Gazette* of the making and approval hereof.

4. Regulation 8E of the principal regulations is revoked, and the following substituted :—

" RATE OF PAYMENT.

"SE. (1) Subject to clause (5) of this regulation, the rate of payment of overtime, where such payment is sanctioned, shall be at a rate equal to the hourly rate of pay of the officer concerned determined as hereinafter set out:

"Provided that the rate shall be not less than one shilling and sixpence an hour.

"(2) The hourly rate of pay shall be determined by dividing the annual rate by 2,080. Fractions of less than a halfpenny are to be assessed at the halfpenny above, and fractions of more than a halfpenny at the penny above.

"(3) Overtime shall be calculated to the nearest quarter of an hour.

"(4) The foregoing provisions shall apply only to officers of the Professional and Clerical Divisions. Officers of the General Division whose cases are not met by special regulation may be paid for overtime at such rate as may be fixed by the Commissioner from time to time.

"(5) For attendance (a) on Sunday, (b) on the holidays set out in Regulation 66, and (c) on other occasions as may be decided from time to time by the Commissioner, overtime payment shall be made at one and a half times the hourly rate of pay calculated as hereinbefore provided :

"Provided that the minimum rate for Sunday and holiday duty shall be 2s. 3d. per hour and the maximum rate 6s. 9d. per hour."

5. Regulation 109 of the principal regulations is revoked, and the following substituted :---

 $^{\prime\prime}$ 109. All officers to whom this part of the regulations applies may receive travelling-allowances for personal expenses at the following rates :—
