THE POST-PRIMARY SCHOOL GRANTS REGULATIONS 1949, AMENDMENT NO. 4

Pursuant to the Education Act 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Post-primary School Grants Regulations 1949, Amendment No. 4, and shall be read together with and deemed part of the Post-primary School Grants Regulations 1949* (hereinafter referred to as the principal regulations).

2. Regulation 3 of the principal regulations, as amended by regulation 2 of the Post-primary School Grants Regulations 1949, Amendment No. 3, is hereby further amended as from the 31st day of January 1954 by revoking paragraph (a), and substituting the following paragraph:

"(a) A grant applicable in accordance with regulation 5 hereof for the general purposes of the school, which grant shall be at a rate ascertained in accordance with the following scale, and shall be increased in the case of any governing body which controls more than one school at the rate of £250 a year for each school in excess of one:

- 3. Regulation 3 of the principal regulations, as amended by regulation 4 of the Post-primary School Grants Regulations 1949, Amendment No. 3, is hereby further amended by omitting from paragraph (b) the words "rate of 15s.", and substituting the words "rate of £1".
- 4. The principal regulations are hereby amended by inserting after regulation 3, the following regulation:
- "3A. The Minister of Education may in the year ending with the 31st day of January 1955 and in each subsequent year ending with the 31st day of January authorize payment to the governing body of any school of such sum as he thinks fit up to a maximum of £2 for each weekly teaching half-day but not exceeding a total sum of £500, for the additional cost of the heating of school premises in new schools or schools where an approved new heating system is installed."
- 5. Regulation 4 of the principal regulations is hereby amended by omitting the words "the last preceding regulation", and substituting the words "regulation 3 and of regulation 3 hereof".
- 6. Regulation 5 of the principal regulations is hereby amended by omitting from subclause (1) the words "of the grant so", and substituting the words "of the additional grant paid to any governing body by reason of the fact that it controls more than one school and of the grant".
- 7. The principal regulations are hereby amended by adding the following regulation:
- "8. (1) For the purpose of meeting the salaries of part-time teachers whose appointments have been approved there shall be paid to the controlling authority of a school a total sum not exceeding the capitation fixed according to subclause (2) hereof.
- "(2) The capitation payable to the controlling authority of a school in respect of part-time teachers who are engaged in the instruction of approved classes or whose appointment is otherwise approved by the Director of Education shall be computed at such a rate for every hour during which those teachers under its control are actually engaged in the performance of their duties as will reimburse the controlling authority the total sum that it is required to pay those teachers at the hourly rates for the time being fixed by the Government Service Tribunal:
- "Provided that the total sum payable under this subclause by way of capitation for any period to a controlling authority in respect of such part-time teachers under its control shall not exceed an amount arrived at by adding—
 - "(a) The amount which is the product of the total number of hours in which male part-time teachers under its control were engaged during that period in the performance of their duties and the average of the range of hourly rates fixed by the Government Service Tribunal for such male part-time teachers during that period; and
 - "(b) The amount which is the product of the total number of hours in which female part-time teachers under its control were engaged during that period in the performance of their duties and the average of the range of hourly rates fixed by the Government Service Tribunal for such female part-time teachers during that period.

"(3) In computing for the purposes of this regulation the amount of capitation payable to any controlling authority, any time during which a teacher is engaged in the performance of his duties during an evening period or on any Saturday shall be computed as time and a quarter."

8. Regulations 2 to 5 of the Post-primary School Grants Regulations 1949, Amendment No. 3 are hereby revoked.

EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

These regulations vary certain of the grants payable to the governing bodies of post-primary schools.
