

THE PRIVATE SCHOOLS INTEGRATION PROGRAMME ORDER 1976

Pursuant to section 7 (1) of the Private Schools Conditional Integration Act 1975, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Private Schools Integration Programme Order 1976.
- (2) This order shall come into force on the day after the date of its notification in the *Gazette*.
- 2. Phased programme approved—Subject to clause 3 of this order, the Minister shall approve the establishment of private schools as integrated schools so that the total amount expended on and in the establishment of private schools as integrated schools, and in respect of integrated schools and private schools the Proprietors of which have indicated to the Director-General their intention that the schools be established as integrated schools—
 - (a) In the year ending with the 31st day of March 1977, does not exceed \$1,000,000:
 - (b) In the year ending with the 31st day of March 1978, does not exceed \$2,470,000:
 - (c) In the year ending with the 31st day of March 1979, does not exceed \$4,940,000:
 - (d) In the year ending with the 31st day of March 1980, does not exceed \$8,230,000:

- (e) In the year ending with the 31st day of March 1981, does not exceed \$12,350,000:
- (f) In the year ending with the 31st day of March 1982, does not exceed \$17,300,000.
- 3. Year ending 31 March 1977—During the year ending with the 31st day of March 1977 expenditure in connection with the establishment of private schools as integrated schools, and in respect of integrated schools and private schools the Proprietors of which have indicated to the Director-General their intention that the schools be established as integrated schools, shall be limited to:

(a) The costs of recruitment and salaries of additional employees

by the Department of Education:

- (b) The costs of recruitment and salaries of additional employees recruited by Education Boards:
- (c) The payment of student allowances and bursaries to students attending the private teachers' training college known as Loreto Hall:

(d) The costs of and incidental to the establishment of the private school known as Wesley College as an integrated school and thereafter its administration as an integrated school:

(e) The payment to Catholic private schools the Proprietors of which have indicated to the Director-General their intention that the schools be established as integrated schools of grants under the Private Schools Grants Regulations 1973.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect. This order approves a phased programme for the establishment of private schools as integrated schools. In the 1976-77 year only Wesley College is to be integrated; and the total expenditure on integration is limited to \$1,000,000. Total expenditure in the years ending 31 March 1978, 1979, 1980, 1981, and 1982 is to be \$2,470,000, \$4,940,000, \$8,230,000, \$12,350,000, and \$17,300,000, respectively.
