THE PUBLIC SERVICE REMUNERATION ORDER 1944

ORDER IN COUNCIL

At the Government House at Wellington, this 20th day of
December, 1944

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 10 of the Finance Act, 1938, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby order as follows:—

1. This Order may be cited as the Public Service Remuneration Order 1944.

2. This Order shall be deemed to have come into force on the 7th day of December 1944.

3. Upon the coming into force of this Order, the Public Service Remuneration Order 1938,* as heretofore amended, shall cease to have any application to officers employed in—

(a) The Public Service administered under the provisions of the Public Service Act, 1912 :

(b) The Post and Telegraph Department :

Provided that nothing herein contained shall affect the continued application thereof to officers employed in the Government Railways Department.

4. The minimum rates of remuneration (exclusive of cost-of-living bonus) for adult officers employed in—

(a) The Public Service administered under the provisions of the Public Service Act, 1912 :

(b) The Post and Telegraph Department—

shall be the rates set out in the First Schedule hereto.

5. The minimum rates of remuneration (exclusive of cost-of-living bonus) for male married officers employed as aforesaid shall be the rates set out in the Second Schedule hereto.

SCHEDULES

FIRST SCHEDULE

MINIMUM RATES OF REMUNERATION FOR OFFICERS OF ADULT AGE

Male Officers :—

- (a) £195 per annum at the age of twenty-one years or over, irrespective of service :
- (b) £205 per annum at the age of twenty-one years or over on completion of five years' permanent service :
- (c) £230 per annum at the age of twenty-one years or over on completion of six years' permanent service :
- (d) £240 per annum at the age of twenty-one years or over on completion of seven years' permanent service increasing to £245 per annum after one year at the rate of £240 per annum :

Provided that message-boy service in the Post and Telegraph Department in excess of three years shall for the purposes of computing minimum rates of remuneration under this Schedule be deemed to be permanent service.

Female Officers : £95 per annum.

SECOND SCHEDULE

MINIMUM RATE OF REMUNERATION FOR MALE MARRIED OFFICERS

- (a) For officers employed at an annual remuneration or annual rate of remuneration, £243 per annum.
- (b) For officers employed at an hourly remuneration or hourly rate of remuneration, 2s. 4d. an hour.
- (c) For officers employed at a remuneration or rate of remuneration otherwise fixed or computed, a rate proportionate to that set out in paragraph (a) of this Schedule.
