THE PUBLIC SERVICE REMUNERATION ORDER 1946

ORDER IN COUNCIL

At the Government House at Wellington, this 7th day of August, 1946

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 10 of the Finance Act, 1938, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby order as follows :—

1. This Order may be cited as the Public Service Remuneration Order 1946.

2. This Order shall be deemed to have come into force on the 30th day of June, 1944.

3. Upon the coming into force of this Order, the Public Service Remuneration Order 1938,* the Public Service Remuneration Order 1938, Amendment No. 1†, the Public Service Remuneration Order 1938, Amendment No. 3‡, and the Public Service Remuneration Order 1944§ are revoked.

4. (1) The minimum rates of remuneration (exclusive of cost-of-living allowance) for adult officers employed in—

(a) The Public Service administered under the provisions of the Public Service Act, 1912 ; or

(b) The Post and Telegraph Department—
shall be the rates set out in the First Schedule hereto.

(2) This regulation shall be deemed to have remained in force until and including the 31st day of March, 1946, and no longer.

5. The minimum rates of remuneration (exclusive of cost-of-living allowance) for male married officers employed as aforesaid shall be the rates set out in the Second Schedule hereto.

SCHEDULES

FIRST SCHEDULE

MINIMUM RATES OF REMUNERATION FOR OFFICERS WHO HAVE ATTAINED THE AGE OF TWENTY-ONE YEARS

Male Officers in the Clerical or Professional Divisions :—

- (a) Irrespective of service : £225 per annum.
- (b) On completion of five years' permanent service : £235 per annum.
- (c) On completion of six years' permanent service : £260 per annum.
- (d) On completion of seven years' permanent service : £270 per annum.
- (e) After one year at £270 per annum : £275 per annum.

Provided that message-boy service in the Post and Telegraph Department in excess of three years shall, for the purposes of computing minimum rates of remuneration under this Schedule, be deemed to be permanent service.

Female Officers : £175 per annum.

SECOND SCHEDULE

MINIMUM RATE OF REMUNERATION FOR MALE MARRIED OFFICERS

- (a) For officers employed at an annual rate of remuneration : £275 per annum.
- (b) For officers employed at an hourly rate of remuneration : 2s. 7½d. per hour.
