

# THE PASSENGER SERVICE VEHICLE CONSTRUCTION **REGULATIONS 1978, AMENDMENT NO. 6**

#### ORDER IN COUNCIL

## Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 199 of the Transport Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Passenger Service Vehicle Construction Regulations 1978, Amendment No. 6, and shall be read together with and deemed part of the Passenger Service Vehicle Construction Regulations 1978\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 28th day after the date of their notification in the Gazette.

2. Plan approval fee increased—(1) Regulation 5 of the principal regulations is hereby amended by revoking subclause (2), and substituting

the following subclauses:

"(2) Every set of plans and specifications supplied for a small passenger service vehicle in pursuance of this regulation shall be accompanied by a fee of \$106.50 (which amount shall be inclusive of any goods and services tax payable under the Goods and Services Tax Act 1985).

"(2A) Every set of plans and specifications supplied for a large passenger service vehicle in pursuance of this regulation shall be accompanied by a fee of \$355.50 (which amount shall be inclusive of any goods and services

tax payable under the Goods and Services Tax Act 1985)."

- (2) Regulation 5 (3) of the principal regulations is hereby amended—
- (a) By inserting, before the word "fee", the word "appropriate":
- (b) By inserting, after the expression "subclause (2)", the expression "or subclause (2A) of this regulation".
- **3. Revocation**—The Passenger Service Vehicle Construction Regulations 1978, Amendment No. 4 and the Passenger Service Vehicle Construction Regulations 1978, Amendment No. 5 are hereby consequentially revoked.

### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force 28 days after the date of their notification in the Gazette, prescribe new fees for plan approvals under the Passenger Service Vehicle Construction Regulations 1978. Formerly, the fee was \$318. The new fees are \$106.50 for small passenger service vehicles and \$355.50 for large passenger service vehicles. The new fees are inclusive of goods and services tax.
