THE PRIMARY TEACHERS' GRADING REGULATIONS 1926, AMENDMENT NO. 4.

GALWAY, Governor-General. ORDER IN COUNCIL.

At the Government House at Wellington, this 3rd day of April, 1940.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

ASSUANT to the Education Act. 1914. His Excellency the Gove

Pursuant to the Education Act, 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

- 1. These regulations shall be cited as the Primary Teachers' Grading Regulations 1926, Amendment No. 4.
- 2. These regulations shall be read together with and form part of the regulations made by Order in Council dated the 30th day of March, 1926 (hereinafter referred to as the principal regulations).
- 3. These regulations shall come into force on the day following notification in the Gazette of the making hereof.*
- 4. Clause 4 of the principal regulations (as substituted by Order in Council dated 11th February, 1935) is revoked, and the following substituted:—
- "4. Teachers entitled to be graded shall be graded in groups, in the case of head and sole teachers, according to the grade of basic salary payable and to the position salary they are entitled to receive, and, in the case of assistant teachers, according to the indicating letter and/or figure designating the grade of basic salary together with the amount of position salary (if any) they are entitled to receive under the Teachers' Salaries Regulations 1938 as follows:—

- 5. Clause 5 of the principal regulations is amended by—
- (1) Revoking in subclause (1) (d) thereof the words "clause 4 of the Regulations for the Salaries of Public School Teachers", and substituting the words "the Teachers' Regulations 1938".
- (2) Revoking subclause (1) (f) thereof, and substituting the following:
 - "A male assistant in a mixed school, a contributing school, and the Correspondence School entitled to receive a salary of A5 shall be graded in Group 4."
- (3) Revoking subclause (1) (q) thereof, and substituting the following:
 - "Teachers who were formerly graded in Group 2 shall be graded in Group 3, except that the Director may, on the recommendation of the grading officers, direct that any such teacher shall be graded in Group 1."
- (4) Revoking subclause (1) (h) thereof, and substituting the following:
 - "Certificated teachers employed in positions in which a basic salary is not payable and relieving teachers shall be graded in Group 1 except that the Director may approve of a relieving teacher being graded in a group higher than Group 1."
