# THE PUBLIC TRUST OFFICE AMENDING REGULATIONS (NO. 2) 1954

## C. W. M. NORRIE, Governor-General ORDER IN COUNCIL

At the Government House at Wellington this 15th day of December 1954 Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Public Trust Office Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

1. (1) These regulations may be cited as the Public Trust Office Amending Regulations (No. 2) 1954, and shall be read together with and deemed part of the regulations made under the Public Trust Office Act 1908 and other Acts on the 20th day of August 1923.\*

(2) These regulations shall come into force on the 1st day of January

1955.

2. Regulation 6 of the Public Trust Office Amending Regulations 1949†, as amended by regulation 2 of the Public Trust Office Amending Regulations 1953, is hereby further amended by omitting the words "3\frac{1}{4} per cent" wherever they appear, and substituting in each case the words '3½ per cent."

3. The Public Trust Office Amending Regulations 1953‡ are hereby

revoked.

### EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

These regulations increase from  $3\frac{1}{4}$  per cent to  $3\frac{1}{2}$  per cent the rate of interest payable on and after 1 January 1955 on money in the Common Fund of the Public Trace Office of the Public Trace Off of the Public Trust Office which is not at call.
