PURSUANT to section 30 (4) of the Public Trust Office Act 1957, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Public Trust Office Regulations 1958, Amendment No. 18, and shall be read together with and deemed part of the Public Trust Office Regulations 1958\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of October 1984.

**2. Common Fund interest**—(1) Regulation 9(1) of the principal regulations (as amended by regulation 2 of the Public Trust Office Regulations 1958, Amendment No. 7 and by regulation 2 of the Public Trust Office Regulations 1958, Amendment No. 17) is hereby amended by omitting from paragraph (a) the expression “10 percent”, and substituting the expression “12 percent”.

(2) Regulation 9(1) of the principal regulations (as amended by regulation 2 of the Public Trust Office Regulations 1958, Amendment No. 7 and by regulation 2 of the Public Trust Office Regulations 1958, Amendment No. 16) is hereby amended by omitting from paragraph (aa) the expression “9 percent”, and substituting the expression “11 percent”.

(3) Subclauses (1) and (2) of this regulation shall not apply to any interest payable in respect of the period that ends with the 30th day of September 1984, and the increases in the rates of interest thereby made shall operate as from that date.

**3. Revocations**—The following regulations are hereby revoked:

EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

Regulation 2 increases from 10 percent to 12 percent the rate of interest payable on or after 1 October 1984 on trust money in the Common Fund of the Public Trust Office when it is not held at call, and increases from 9 percent to 11 percent the rate of interest payable on or after 1 October 1984 on money held otherwise than at call in a Government fund or a local authority fund.
