ORDER IN COUNCIL

At the Government House at Wellington this 4th day of August 1980

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 4 of the Plant Varieties Act 1973, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Plant Varieties Act Extension Order 1980.
- (2) This order shall come into force on the 14th day after the date of its notification in the Gazette.
 - 2. Application of Act—The Plant Varieties Act 1973 shall apply to—
 (a) Agricultural and vegetable crops, being—

(i) Barley (Hordeum sp.):

- (ii) Brassica varieties (Brassica sp.) of agricultural importance such as turnips, swedes, kale, and rape, but excluding vegetable varieties such as cabbage, cauliflower, broccoli, and Brussel sprouts:
 - (iii) Linseed (Linum usitatissimum L.):
 - (iv) Lucerne (Medicago sativa L.):

(v) Oats (Avena sp.):

- (vi) Peas, field and garden, (Pisum sp.):
- (vii) Phacelia (Phacelia tanacetifolia Benth.):
- (viii) Potatoes (Solanum tuberosum L.):
- (ix) Wheat (Triticum sp.):
- (b) Fruit, being—
 - (i) All fruit species except those species such as tomatoes and aubergines commonly termed vegetables:
 - (ii) All nut species:

(c) Herbage, being-

- (i) Fescue (Festuca sp.):
- (ii) Lotus (Lotus sp.):
- (iii) Phalaris (Phalaris sp.):
- (iv) Ryegrass (Lolium sp.):
- (v) Yorkshire Fog (Holcus lanatus):
- (d) Ornamentals, being all ornamental species except Orchidaceae (other than Cymbidium sp.).
- 3. Revocation—The Plant Varieties Act Extension Order 1979* is hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect. This order extends the application of the Plant Varieties Act 1973 to fully cover all fruit and ornamental species, and makes a more limited extension in respect of agricultural crop species of kale, rape, linseed, and phacelia, and herbage species of fescue and phalaris.
