ORDER IN COUNCIL

At Wellington this 9th day of October 1989

HIS EXCELLENCY THE GOVERNOR GENERAL IN COUNCIL

PURSUANT to section 38 of the Plant Variety Rights Act 1987, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Plant Variety Rights (Fees) Order 1989.

(2) This order shall come into force on the 28th day after the date of its notification in the *Gazette*.

2. Fees—(1) The fees specified in the Schedule to these regulations must be paid in respect of the things referred to (being things authorised by the Plant Variety Rights Act 1987) in that schedule.

(2) Where, at the request of an applicant, the Commissioner arranges an overseas test trial of a variety, the applicant must pay the Commissioner the cost of the trial.

3. Amount of GST included—The fees prescribed in this order are inclusive of goods and services tax under the Goods and Services Tax Act 1985.

4. Revocation-The Plant Variety Rights (Fees) Order 1988 is hereby consequentially revoked.
