THE PHYSICAL WELFARE AND RECREATION (FEES AND ALLOWANCES OF MEMBERS OF NATIONAL COUNCIL) REGULATIONS 1938.

ORDER IN COUNCIL.

At the Government Buildings at Wellington, this 13th day of December, 1938,

Present:

THE RIGHT HON. M. J. SAVAGE PRESIDING IN COUNCIL.

In pursuance and exercise of the power and authority conferred on him by the Physical Welfare and Recreation Act, 1937, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the regulations hereinafter set forth.

REGULATIONS.

- 1. These regulations may be cited as the Physical Welfare and Recreation (Fees and Allowances of Members of National Council) Regulations 1938.
- 2. These regulations shall come into force on the day following notification thereof in the Gazette.*

INTERPRETATION.

- 3. In these regulations, if not inconsistent with the context.—
 - "Act" means the Physical Welfare and Recreation Act, 1937:
 - "Council" means the National Council of Physical Welfare and Recreation established under the Act:
 - "Business of the Council" means any business authorized by the Act to be performed by the Council or any member thereof, and includes, when not otherwise mentioned, a meeting of the Council or of any Committee of the Council:
 - "Member" means for the purpose of these regulations a member of the Council other than the Chairman and officers of the Public Service.

FEES.

4. There shall be paid to each member of the Council a fee of £1 1s. for each complete day or part of a day on which he is actually engaged in transacting the business of the Council. This fee is not payable in respect of time occupied in travelling.

Travelling-expenses.

- 5. (1) There shall be paid to each member of the Council all travelling and locomotion expenses (including the cost of sleeping-berths on trains and deck-accommodation on steamers) actually and reasonably expended in travelling in connection with the business of the Council. State services are to be utilized wherever available.
- (2) In exceptional cases the Minister of Internal Affairs may approve of a member of the Council travelling in his own conveyance in transacting any business of the Council. The mileage rate shall be the same as that payable to officers of the Public Service.

TRAVELLING-ALLOWANCES.

6. (1) There shall be paid to each member of the Council the sum of £1 5s. as a travelling-allowance for personal expenses for each complete day on which he is absent from his headquarters in connection with the business of the Council. For any portion of a day the rate shall be one twenty-fourth of the full daily rate for each hour's absence.

(2) When a member leaves and returns to his usual headquarters on the same day, fee and actual and reasonable expenses only shall

be paid.
