# THE PUBLIC WORKS (FEES FOR DOCUMENTS) REGULATIONS 1989, AMENDMENT NO. 1

## ORDER IN COUNCIL

At Wellington this 8th day of June 1993

#### Present:

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 243 (1) of the Public Works Act 1981 and section 80 of the Survey Act 1986, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Public Works (Fees for Documents) Regulations 1989, Amendment No. 1, and shall be read together with and deemed part of the Public Works (Fees for Documents) Regulations 1989\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 28th day after the date

of their notification in the Gazette.

**2. Fees**—(1) Regulation 3 of the principal regulations is hereby amended by inserting, after subclause (1), the following subclauses:

"(1A) For any work carried out by the Department of Survey and Land Information under the Public Works Act 1981 (including, but not limited to, the giving of advice), being additional to the work necessary to process an accurate and correctly presented application, there shall be payable a charge calculated by the Director-General, which shall comprise—

"(a) The costs of salaries incurred in respect of the provision of the work;

and

"(b) A reasonable overhead charge; and

"(c) Goods and services tax payable under the Goods and Services Tax Act 1985.

"(1B) Reasonable disbursements incurred by the Department in relation to any matter in respect of which a fee or charge is payable under these

regulations shall be payable in addition to that fee or charge.

"(1c) For the purposes of subclause (1B) of this regulation, it is hereby declared that the cost of publishing any notice or other document in the *Gazette* is a reasonable disbursement under that subclause and is payable in addition to the appropriate fee prescribed in the Schedule to these regulations."

(2) Regulation 3 (2) of the principal regulations is hereby amended by

omitting the words "of Lands".

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on the 28th day after the date of their notification in the *Gazette*, provide for new charges under the Public Works (Fees for Documents) Regulations 1989 for work carried out by the Department of Survey and Land Information. The new charges are—

(a) A time-based charge in respect of work carried out by the Department in addition to the work necessary to process an accurate and correctly presented application:

(b) Reasonable disbursements incurred by the Department.
