ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Quarantine (Armed Forces) Emergency Regulations 1943.

APPLICATION OF THESE REGULATIONS

2. These regulations apply with respect to all ships and aircraft that are for the time being under the control of any of the Armed Forces of His Majesty or of any of His Majesty's Allies in the present war, and with respect to all persons and goods carried on or in any such ship or aircraft.

**MODIFICATION OF QUARANTINE PROVISIONS OF THE HEALTH ACT, 1920,
IN THEIR APPLICATION TO SHIPS, AIRCRAFT, PERSONS, AND GOODS
TO WHICH THESE REGULATIONS APPLY**

3. Notwithstanding anything to the contrary in Part IV of the Health Act, 1920, or in any regulations relating to quarantine made under the said Act, the Minister of Health may in respect of any ships, aircraft, persons, or goods to which these regulations apply dispense with the observance by Port Health Officers, or by masters of ships, or other persons of all or any of the requirements of the said Act and regulations in relation to quarantine, if he is satisfied that the military or other authorities concerned have made satisfactory arrangements or have undertaken to make arrangements for the inspection, disposition, and treatment of such ships, aircraft, passengers, and goods with a view to preventing the entry into New Zealand of any infectious or communicable disease.

4. (1) For the purpose of giving effect to any arrangements made as aforesaid the authorities having control of any ship or aircraft may appoint such Inspectors or other officers as they think fit, and every person so appointed shall, subject to the terms of his appointment, have the same authority as a Port Health Officer to give directions with respect to the inspection, movement, disposition, or treatment of any ships, aircraft, persons, or goods to which these regulations apply.

(2) It shall be the duty of all Port Health Officers and other persons appointed for the purposes of the Health Act, 1920, to co-operate, as far as practicable, with all Inspectors and other persons engaged in carrying out any quarantine functions in relation to ships, aircraft, persons, and goods to which these regulations apply.

5. Nothing in these regulations shall be construed to deprive any Port Health Officer or other person acting under the Health Act, 1920, of authority to give any directions or to make any order for the purposes of Part IV of that Act, as extended by section 11 of the Health Amendment Act, 1940.
