PURSUANT to the Health Act, 1920, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Quarantine Regulations 1921, Amendment No. 4, and shall be read together with and deemed part of the Quarantine Regulations 1921* (hereinafter called the principal regulations).
- 2. These regulations shall come into force on the 1st day of April, 1947.
- 3. Form (1) in the First Schedule to the principal regulations is hereby revoked, and the following form substituted therefor:—
