PURSUANT to section 39 of the Quantity Surveyors Act 1968, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Quantity Surveyors Regulations 1969, Amendment No. 3, and shall be read together with and deemed part of the Quantity Surveyors Regulations 1969* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 14th day after the date of their notification in the Gazette.
- 2. Fees—(1) Regulation 17 of the principal regulations (as amended by regulation 2 (1) of the Quantity Surveyors Regulations 1969, Amendment No. 2) is hereby amended—
 - (a) By omitting from subclause (1) the expression "\$40.00", and substituting the expression "\$60.00":
 - (b) By omitting from subclause (2) the expression "\$10.00", and substituting the expression "\$15.00":

- (c) By omitting from subclause (5) the expression "\$15.00", and substituting the expression "\$30.00".
 (2) Regulation 40 of the principal regulations (as inserted by regulation 2 of the Quantity Surveyors Regulations 1969, Amendment No. 1, and amended by regulation 2 (2) of the Quantity Surveyors Regulations 1969, Amendment No. 2) is hereby amended by omitting from subclause (2) the expression "\$10.00", and substituting the expression "\$30.00".
- **3. Forms**—The Schedule to the principal regulations (as amended by regulation 3 of the Quantity Surveyors Regulations 1969, Amendment No. 2) is hereby amended—
 - (a) By omitting from form 3 the expression "\$40.00", and substituting the expression "\$60.00":
 - (b) By omitting from form 4 the expression "\$15.00", and substituting the expression "\$30.00".
- **4. Revocation**—Regulations 2 (1) and 3 (a) and (c) of the Quantity Surveyors Regulations 1969, Amendment No. 2 are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations increase the fees for applications for registration, annual practising certificates, and written examinations for quantity surveyors.
