REGULATIONS UNDER THE PUBLIC TRUST OFFICE ACT, 1908

WHEREAS by Order in Council dated the 20th day of August, 1923, and published in the New Zealand Gazette of the 23rd day of August, 1923,* as amended by Orders in Council of the 10th day of November, 1925†, the 1st day of August, 1927‡, the 24th day of March, 1928, the 18th day of December, 1931s, the 20th day of May, 1932, and the 27th day of March, 1933¶, respectively, regulations were made under the authority of the Acts therein recited, inter alia, prescribing the rates of interest payable on moneys in the Common Fund of the Public Trust Office: And whereas it is desirable to amend such regulations in the manner hereinafter set forth: Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred by the Public Trust Office Act, 1908, section 32, and of all other powers and authorities in this behalf him enabling, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby make the regulations set out in the Schedule hereto, and doth order that the regulations hereby made shall come into force on and from the 1st day of April, 1945.

SCHEDULE

PARAGRAPH 1 of the regulations made by Order in Council dated the 10th day of November, 1925, as amended by Orders in Council of the 1st day of August, 1927, the 24th day of March, 1928, the 18th day of December, 1931, the 20th day of May, 1932, and the 27th day of March, 1933, respectively, is hereby further amended by deleting the words "3½ per cent." and "2 per cent." wherever they appear, and by inserting in lieu thereof the words "3½ per cent." and "1½ per cent." respectively.
