1 Title

- (1) This notice is the Securities Act (Charitable and Other Purposes) Exemption Notice 1997 Amendment Notice (No 2) 2002.
- (2) In this notice, the Securities Act (Charitable and Other Purposes) Exemption Notice 1997¹ is called “the principal notice”.

2 Commencement

This notice comes into force on the day after the date of its notification in the *Gazette*.

3 Expiry

Clause 1(3) of the principal notice is amended by omitting the expression “30 November 2002”, and substituting the expression “31 March 2003”.

Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on the day after the date of its notification in the *Gazette*, extends the expiry date of the Securities Act (Charitable and Other Purposes) Exemption Notice 1997 (“the principal notice”) from 30 November 2002 to 31 March 2003.

The principal notice is to be replaced soon by the Securities Act (Charitable and Religious Purposes) Exemption Notice 2002. This further extension of the principal notice’s expiry date allows charitable organisations a smoother transition to the new notice.
