



State-Owned Enterprises (AgriQuality Limited) Order 2004

Order in Council

At Wellington this 5th day of April 2004

Present:

Her Excellency the Governor-General in Council

Pursuant to section 30A of the State-Owned Enterprises Act 1986, Her Excellency the Governor-General makes the following order, acting—

- (a) on the advice and with the consent of the Executive Council; and
- (b) on the recommendation of the Minister for State-Owned Enterprises, who is satisfied that—
 - (i) the name of the State enterprise known as Agriquality New Zealand Limited has been changed to AgriQuality Limited; and
 - (ii) a certificate of incorporation recording that change of name and dated 1 August 2003 has been issued to that State enterprise under section 23(3)(b) of the Companies Act 1993.

1 Title

This order is the State-Owned Enterprises (AgriQuality Limited) Order 2004.

2 Commencement

This order comes into force on the 28th day after the date of its notification in the *Gazette*.

3 Amendment to State-Owned Enterprises Act 1986

The State-Owned Enterprises Act 1986 is amended by omitting from the First Schedule and the Second Schedule the words “Agriquality New Zealand Limited” in both places where they appear, and substituting in each case the words “AgriQuality Limited”.

4 Amendment to other enactments

The enactments specified in the Schedule are amended in the manner indicated in that schedule.

Schedule Other enactments amended

Part 1 Acts amended

Income Tax Act 1994 (1994 No 164)

Omit from Schedule 18 the words “Agriquality New Zealand Limited” and substitute the words “AgriQuality Limited”.

Ministry of Agriculture and Forestry (Restructuring) Act 1998 (1998 No 106)

Omit from paragraph (a) of the definition of **new company**, or **company**, in section 2, the words “Agriquality New Zealand Limited” and substitute the words “AgriQuality Limited”.

Part 1—*continued***Ombudsmen Act 1975** (1975 No 9)

Omit from Part II of the First Schedule the words “Agriquality New Zealand Limited” and substitute the words “AgriQuality Limited”.

Part 2
Regulation amended**Dairy Industry Restructuring (Raw Milk) Regulations 2001**
(SR 2001/326)

Revoke paragraph (c) of the definition of **organic milk** in regulation 3(1) and substitute:

“(c) AgriQuality Limited”.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on the 28th day after the date of its notification in the *Gazette*, amends a number of enactments by changing references to the name of a State enterprise to reflect the change in the name of the State enterprise from Agriquality New Zealand Limited to AgriQuality Limited.
