



**THE SECOND NEW ZEALAND EXPEDITIONARY FORCE PAY  
AND ALLOWANCES EMERGENCY REGULATIONS 1945**

**ORDER IN COUNCIL**

At the Government House at Wellington, this 7th day of  
November, 1945

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

**REGULATIONS**

**PART I.—PRELIMINARY**

1. These regulations may be cited as the Second New Zealand Expeditionary Force Pay and Allowances Emergency Regulations 1945.

2. (1) The Second New Zealand Expeditionary Force Pay and Allowances Emergency Regulations 1941\* are hereby revoked.

(2) All payments, allowances, grants, allotments, issues, credits, debits, forfeitures, cancellations, suspensions, reductions, increases, variations, claims, vouchers, directions, determinations, approvals, and generally all acts of authority that originated under any of the provisions of the regulations hereby revoked and are subsisting or in force at the commencement of these regulations, shall enure for the purposes of these regulations as if they had originated under the corresponding provisions of these regulations, and accordingly shall, where necessary, be deemed to have so originated.

(3) All matters and proceedings commenced under the regulations hereby revoked and pending or in progress at the commencement of these regulations may be continued, completed, and enforced under these regulations.

**INTERPRETATION**

3. In these regulations, unless the context otherwise requires,—  
“Date of embarkation”, in relation to any member, means the day on which the overseas pay records are opened in respect of that member or the seventh day before the date of the member’s actual departure from New Zealand for service overseas, whichever of the said days is the later :

“ Minister ” means the Minister of Defence :

“ Regular Force ” means the Permanent Force for the time being embodied under the provisions of section 14 of the Defence Act, 1909 :

“ Second New Zealand Expeditionary Force ” means the Second New Zealand Expeditionary Force established under the Expeditionary Force Emergency Regulations 1940,\* and includes any section of that Force, whether established before or after the commencement of these regulations :

“ Service overseas ”, in relation to any member who is enlisted in New Zealand, means any period commencing on the date of embarkation of that member and ending on the date on which he returns to New Zealand or on which he is struck off the strength of the Second New Zealand Expeditionary Force, whichever is the earlier ; and, in relation to any member who is enlisted out of New Zealand, means the period commencing on the expiration of ninety-one days after the date of the commencement of his service or on the date of his embarkation for a theatre of war, whichever is the earlier, and ending on the date on which he returns to New Zealand or on which he is struck off the strength of the Second New Zealand Expeditionary Force, whichever is the earlier :

Expressions defined in the Defence Act, 1909, or in any regulations made thereunder, have the meanings so defined.

#### APPLICATION OF THESE REGULATIONS

4. (1) Subject to the provisions of this regulation, these regulations shall apply with respect to —

- (a) Every member of the Second New Zealand Expeditionary Force :
- (b) Every member of the New Zealand Army Nursing Service who is for the time being serving with the Second New Zealand Expeditionary Force :
- (c) Every member of the Women’s Army Auxiliary Corps (Overseas Section) :
- (d) Every representative of the Young Men’s Christian Association, or of the Church Army, or of any other social welfare organization who is duly appointed for service with the Second New Zealand Expeditionary Force.

(2) While any member of the Regular Force who is for the time being serving with the Second New Zealand Expeditionary Force is being paid at the rates prescribed for members of the Regular Force, such of the provisions of these regulations as are specified in the First Schedule hereto shall apply with respect to that member to the extent set out in that Schedule. Except as provided in this subclause, the provisions of these regulations shall not apply with respect to any such member of the Regular Force as aforesaid while he is being paid at those rates.

(3) Notwithstanding anything contained in these regulations, such of the provisions of these regulations as are specified in the Second Schedule hereto shall not apply with respect to any member of the Women’s Army Auxiliary Corps.

## PART II.—PAY

## DAILY RATES OF PAY

5. (1) From and including the day on which the member comes on pay the pay of a member, not being a member of the Women's Army Auxiliary Corps (Overseas Section), shall be at the daily rates set out below :—

(3) Pay and allowances may be issued from and including the day on which the member is given embarkation leave, notwithstanding that he may not have been previously mobilized into camp.

DEFERRED PAY

6. (1) Deferred pay at the rate of 1s. a day shall be credited to every member's account for the period of his service overseas.

(2) Deferred pay shall become payable in the case of an officer when he is struck off the strength of the Second New Zealand Expeditionary Force and ceases to be employed on full-time service or dies while still a member, and in the case of any other member when he is discharged or placed on indefinite leave without pay or dies while still a member :

Provided that—

- (a) Deferred pay shall not become payable in respect of any period during which the member's unallotted pay ceases to be payable in terms of Regulation 37 hereof or during any period of overseas leave wherever taken :
- (b) By direction of the Minister, the member may forfeit his right to deferred pay by reason of his misconduct :
- (c) Any debit balance in the account of a member who is struck off the strength of the Second New Zealand Expeditionary Force shall be recovered by setting off such debit against the amount of his deferred pay under this regulation.

(3) In the case of any member of the Regular Force entitled to deferred pay, it shall be payable when the member is struck off the strength of the Second New Zealand Expeditionary Force and is considered by the Adjutant-General to have ceased to be liable for further overseas service.

EXTRA-DUTY PAY AND TRADESMEN'S PAY

7. (1) The extra-duty pay of a member while carrying out the duties of cook shall be 2s. 6d. a day. Such extra-duty pay may be paid while the member is carrying out the duties of cook on board a transport or troopship proceeding overseas.

(2) A lance-corporal or soldier carrying out the duty of armourer, artificer, baker, bootmaker, butcher, dental mechanic, draughtsman, driver-mechanic, electrician, engine-driver, equipment-repairer, fitter,

instrument mechanic, motor mechanic, or orderly-room clerk shall receive, in addition to ordinary pay, tradesmen's pay at the rate of 1s. a day :

Provided that the number of lance-corporals or soldiers receiving tradesmen's pay shall not exceed that prescribed in the establishment of the member's unit :

Provided also that such tradesmen's pay shall not be paid while the member is on board a transport or troopship.

(3) A lance-corporal or soldier carrying out the duty of nursing orderly in connection with the treatment of venereal disease shall receive extra-duty pay at the rate of 1s. a day, whether or not such duties are being carried out on board a transport or troopship.

(4) (a) Where extra-duty pay of cooks or tradesmen's pay is payable to any member it shall continue to be payable to him, notwithstanding that he may proceed to a change-of-air camp. Such pay will not be payable to any other member who substitutes for him on that period of leave.

(b) In other cases where temporary cessation of the duties for which extra-duty pay is payable does not exceed seven days and the vacancy in establishment caused thereby is not filled, extra-duty pay may continue to be payable, and no casualty report of the cessation need be rendered. If the cessation exceeds seven days, the extra-duty pay will cease to be payable after the said period of seven days, except as provided in subparagraphs (5) and (6) hereafter.

(5) While any member to whom extra-duty pay of cooks or tradesmen's pay is payable is a prisoner of war the extra-duty pay or tradesmen's pay shall continue to be payable. If the member returns to the Second New Zealand Expeditionary Force, such extra-duty pay or tradesmen's pay shall cease on the expiration of fourteen days from the date of his return, unless he is immediately appointed to fill a vacancy for which extra-duty pay or tradesmen's pay is payable.

(6) Extra-duty pay of cooks and tradesmen's pay shall continue for a period of three months after the date on which notification of the member's death (whether or not he is a prisoner of war), or of his being reported missing, is sent to his next-of-kin.

(7) A lance-corporal or soldier employed on a transport as assistant in bakery or in butchery, or both, shall be paid extra-duty pay at the rate of 1s. a day.

(8) Members who attend courses of instruction at Service schools for the purpose of acquiring additional knowledge, or who take refresher courses, shall continue to receive extra-duty or tradesmen's pay. No increased remuneration shall be paid to members who act as reliefs during the absence of the qualified men.

(9) While any member is engaged in parachute duties in Australia or with the Australian Forces he shall receive, in addition to pay of rank, pay at the following rates :—

(a) At the rate of 2s. a day for the period from and including the day upon which the member is taken on trainee strength of a parachute-training unit up to and including the day before the day on which the member becomes a qualified parachutist :

(b) At the rate of 1s. a day extra for every day on which during his training the member makes one or more parachute descents from an aircraft :

(c) On becoming a qualified parachutist, while he is a member of a parachute unit, at the rate of 3s. a day :

Provided that if, after qualification, the member does not during any period of six months make a parachute descent from an aircraft, he shall on and after the day following the date upon which such period expires cease to be entitled to any additional pay until he next makes a parachute descent as a member of a parachute unit, in which case the additional pay shall become payable on and from the day of that descent.

(10) While any member is engaged in parachute duties with a parachute formation or unit in the Middle East or any other theatre of war the rate of extra-duty pay shall be in accordance with the British Army rates for such parachute duties.

#### PAY AND ALLOWANCES OF Y.M.C.A. FIELD SECRETARIES AND CHURCH ARMY SECRETARIES

8. Every Y.M.C.A. Field Secretary or Church Army Secretary on appointment for service overseas with the Second New Zealand Expeditionary Force shall be paid, from the date of commencement of service until the date on which he is struck off the strength of the Second New Zealand Expeditionary Force, the pay and allowances of a Warrant Officer, Class I.

#### PAY AND ALLOWANCES OF A MEMBER OF THE REGULAR FORCE SECONDED FOR DUTY

9. (1) If any member of the Regular Force seconded for duty to the Second New Zealand Expeditionary Force so requests, he shall, instead of receiving the pay and allowances prescribed for the Regular Force by regulations made under the Defence Act, 1909, receive the pay and allowances prescribed by these regulations according to the rank which he holds in the Second New Zealand Expeditionary Force.

(2) Except with the approval of the Minister or of some person authorized by the Minister in that behalf, no member of the Regular Force who elects under this regulation to be paid at the rates prescribed by these regulations shall, while remaining seconded as aforesaid, revert to Regular Force rates of pay.

(3) If any member of the Regular Force, while serving with the Second New Zealand Expeditionary Force, is reduced by a court-martial to a rank lower than that which he holds in the Regular Force he shall receive pay at Second New Zealand Expeditionary Force rates for the rank to which he is so reduced.

#### LEAVE

10. Any member may be granted leave in New Zealand, with or without pay, for such periods and on such terms and conditions as are or may from time to time be approved by the Minister.

#### PAY WHILE A MEMBER IS IN A MILITARY HOSPITAL FOR VENEREAL DISEASE

11. (1) For each day on which any member, not being a member of the Women's Army Auxiliary Corps, undergoes military hospital treatment for venereal disease, the sum of 2s. shall be deducted from that member's pay :

Provided that—

- (a) The medical officer may at his absolute discretion, taking into consideration the circumstances of the case, direct that the deduction shall be at the rate of 1s. a day :
- (b) Where the member having on enlistment been pronounced by a medical board as free from venereal disease suffers during the period of his service a recrudescence of venereal disease contracted before enlistment, and the medical officer certifies that the recrudescence has been brought about by conditions of service, and the member's commanding officer concurs, no deduction shall be made from the member's pay.

(2) For each day on which any member of the Women's Army Auxiliary Corps undergoes treatment for venereal disease the sum of 1s. shall be deducted from her pay :

Provided that the medical officer may in his absolute discretion, taking into consideration the circumstances of the case, direct that no deduction shall be made.

#### PAY WHILE A MEMBER IS A PRISONER OF WAR

12. (1) No member, being a prisoner of war, shall forfeit his right to pay unless a Court of inquiry convened by order of an officer commanding declares that the member was taken prisoner through his own neglect or misconduct.

(2) The adjustment of the pay accounts of members who are prisoners of war shall be made in such manner as the Minister may from time to time direct.

#### CONTINUANCE OF ALLOTTED PAY : MEMBER REPORTED MISSING OR DEAD

13. (1) Where a member, not being a member already reported dead, is reported missing, or where a member, not being a member already reported missing, is reported dead, his allotted pay shall, if the death has occurred in New Zealand, continue to be paid for a period of three months from the date of death, and shall in any other case continue to be paid for a period of three months immediately following the date on which notification of the casualty is sent to the member's next-of-kin :

Provided that where the member, while serving in New Zealand, dies leaving no dependants, and his death is not attributable to service in the Armed Forces, his allotted pay shall cease at the date of his death.

(2) Where a member is reported missing and subsequently reported dead, or, not having previously been reported as a prisoner of war, is reported to have died while a prisoner of war, his allotted pay shall continue to be paid for the period of three months immediately following the date on which notification of the fact that the member is missing is sent to the next-of-kin or immediately following the actual date of death, whichever is the later date.

(3) Payments being made to a dependant for any period of three months in accordance with this regulation shall continue to be paid during that period, notwithstanding the death or remarriage or change of circumstances of any dependant during that period.

CONTINUANCE OF UNALLOTTED PAY : MEMBER REPORTED MISSING  
OR DEAD

14. During any period for which any member's allotted pay continues to be payable pursuant to the provisions of Regulation 13 hereof, the member's unallotted pay shall continue to be credited to the member or to his estate, as the case may require :

Provided that nothing in this regulation shall be deemed to affect the member's rights regarding his pay if, having been posted missing, he is subsequently found to be alive :

Provided also that where a member dies while serving in New Zealand and his death is not attributable to service in the Armed Forces his unallotted pay shall cease at the date of his death.

PAY OF ACTING RANK AND TEMPORARY RANK

15. (1) No member holding an acting rank shall be entitled to the pay and allowances of that rank, but that member shall continue to draw the pay and allowances prescribed for his substantive rank, or, if he is also holding a temporary rank, the pay and allowances of that temporary rank.

(2) Every member holding a temporary rank shall, while he is actually performing the duties pertaining to that rank, be entitled to receive pay and allowances at the rate prescribed for the substantive rank equivalent to that temporary rank.

(3) Where any member is shown to be a prisoner of war, missing, or dead, and that member was holding temporary rank immediately before being so shown, pay for that temporary rank shall be credited to the member or to his estate, as the case may require.

ALLOTMENT OF PAY

16. (1) Except as otherwise directed by the Minister, every officer, and every member of the New Zealand Army Nursing Service or of the Women's Army Auxiliary Corps (Overseas Section), shall, from and including the day on which that officer or member comes on pay, allot from his or her pay to a person wholly or partly dependent on the officer or member, or to a trustee, attorney, responsible agent for business purposes, bank, or financial institution, or to an accredited relative, or to a post-office savings-bank account which will be opened at the General Post Office, Wellington, in the name of the officer or member, an amount in accordance with the following scale :—

Provided that no member of the Women's Army Auxiliary Corps shall be required to make an allotment in respect of any period during which she is in New Zealand.

(2) Except as otherwise directed by the Minister, every warrant officer, non-commissioned officer, and soldier shall, from and including the day on which he comes on pay, allot from his pay to a person wholly or partly dependent on him, or to a trustee, attorney, responsible agent for business purposes, bank, or financial institution, or to an accredited relative, or to a post-office savings-bank account which will be opened at the General Post Office, Wellington, in the name of the warrant officer, non-commissioned officer, or soldier, an amount in accordance with the following scale :—

#### ALLOTMENT OF PAY : MAXIMUM ALLOTMENT

17. (1) Except as otherwise directed by the Minister or by any person authorized by the Minister in that behalf, no member shall allot from his pay any sum which would, if so allotted, preclude the member from drawing for himself at least 2s. a day of his pay.

(2) No member shall allot any extra-duty pay.

#### ALLOTMENT OF PAY : VARIATION AND PROHIBITION

18. (1) No member shall, except with the approval of the Minister or of any person authorized by the Minister in that behalf, alter or vary any allotment of pay.

(2) The Minister may, in the case of any member, prohibit the making by that member of an allotment of pay or any part of such an allotment, or may direct that any member shall allot from his pay either less or more than the amount prescribed by Regulation 16 hereof.

#### ALLOTMENT OF PAY : GENERAL

19. Except as otherwise provided by these regulations or as otherwise approved by the Minister or any person authorized by the Minister in that behalf, any member may allot any sum from his pay in favour of a person wholly or partly dependent on him, a trustee, attorney, responsible agent for business purposes, bank, financial institution, or accredited relative, or to a post-office savings-bank account which will be opened at the General Post Office, Wellington, in the name of the member.

#### DEDUCTION FROM PAY

20. There may from time to time be deducted from the pay of any member such sum or sums as the Minister thinks necessary—

(a) For the support of any person who in the opinion of the Minister is wholly or partly dependent upon or has a claim for maintenance against the member; and all sums so deducted may, as the Minister thinks fit, be paid to the dependent person or to some other person on the dependent person's behalf and for the dependent person's benefit; or

(b) For any other special purpose approved by the Minister :

Provided that no amount shall be deducted under this regulation which would, if so deducted, preclude the member from drawing for himself at least 2s. a day of his pay.

PART III.—ALLOWANCES

EMBARKATION ALLOWANCE

21. (1) There shall be payable to every member before he proceeds overseas the sum of £3 by way of embarkation allowance :

Provided that the allowance shall be paid only once in respect of one period of service with the Second New Zealand Expeditionary Force, and where any subsequent embarkation leave is granted during the same period of service, a subsistence allowance under Regulation 22 hereof shall be payable in respect of the period of that leave.

(2) In any case where embarkation leave cannot be granted the embarkation allowance shall be paid and known as " Bonus in lieu of Embarkation Leave ". Such bonus shall be paid notwithstanding that the member may not previously have been mobilized into camp.

SUBSISTENCE ALLOWANCE

22. (1) While any member is on full-time service in New Zealand and is entitled to pay or allotted pay only, and is not provided with rations and quarters, there may, upon and subject to such conditions as may from time to time be prescribed, be paid to that member a subsistence allowance at the following rate, namely :—

(2) No member shall be entitled to a subsistence allowance—

(a) For any period of embarkation leave in respect of which an embarkation allowance is paid to the member under Regulation 21 hereof :

(b) For any other period of leave of absence which is less than seventy-two hours in duration :

Provided that if when the member proceeds on leave of absence he is being paid a subsistence allowance he shall during the whole of the period of leave, whether or not the leave is for less than seventy-two hours, be paid a subsistence allowance at the rate of 3s. a day.

(3) Every soldier granted overseas leave shall be paid a subsistence allowance of 4s. 6d. a day during the period of his overseas leave.

(4) Any member serving beyond New Zealand, including any officer dismissed abroad and returning to New Zealand, who is not provided with free quarters, may be paid an allowance of 4s. a day, and when not provided with rations may be paid an additional allowance of 3s. a day :

Provided that any officer, and any member of the New Zealand Army Nursing Service or of the Women's Army Auxiliary Corps (Overseas Section), who is required to live, on duty, in a large town where rations and quarters are not provided may, in lieu of the allowance provided for in this subclause, be paid an allowance not exceeding 15s. a day.

(5) Any member serving beyond New Zealand may be paid a subsistence allowance of 3s. a day for all periods of privilege leave (not being week-end leave) of forty-eight hours or more.

(6) A special allowance for members in the United Kingdom living in London, who are not rationed or quartered, may be paid as follows:—

#### MESS ALLOWANCE

23. (1) Any officer attached to a unit of any Force, other than the Second New Zealand Expeditionary Force, whether for courses of instruction or for any other purpose, may be paid a mess allowance not exceeding 3s. a day. Other ranks similarly attached may be paid such money-compensation, not exceeding 3s. a day, as is adequate to cover messing-expenses.

(2) There may be paid to members of the New Zealand Army Nursing Service or of the Women's Army Auxiliary Corps in New Zealand convalescent depots and rest homes overseas a mess allowance of an amount to be fixed from time to time.

(3) Any officer sent to India for training may be paid a mess allowance of 6½ rupees a day.

(4) A ration and mess allowance of not more than 2 dollars a day may be paid to any officer while he is attached to any United States formation or organization:

Provided that where free rations are provided only the allowance provided for in subclause (1) of this regulation shall be paid.

#### RATION ALLOWANCE : CONVALESCENT LEAVE

24. Any member serving overseas who is granted a definite period of sick-leave may be paid as a ration allowance the sum of 3s. a day for a period not exceeding twenty-eight days:

Provided that any officer, or any member of the New Zealand Army Nursing Service or of the Women's Army Auxiliary Corps (Overseas Section) who is not accommodated in a convalescent hospital may, in lieu of the ration allowance, be paid an allowance of 10s. a day.

#### RATES OF TRAVELLING-ALLOWANCE

25. (1) Subject to the provisions of Regulations 26 to 28 hereof, a travelling-allowance in accordance with this regulation may be paid to members who are absent on defined duty from their stations or headquarters.

(2) In the case of members required to travel in or to Australia, whether visiting Australia from New Zealand or proceeding through Australia from or to New Zealand, and travelling otherwise than in a transport or hospital ship, the rates of travelling-allowance shall be in accordance with the following scale:—

(5) In addition to the above-mentioned rates, any officer, or any member of the New Zealand Army Nursing Service or of the Women's Army Auxiliary Corps (Overseas Section), may claim a refund for the cost of a sleeping-berth if the berth was actually used while travelling by train and if a receipt for the cost is produced. Where a "special" sleeping-berth is used that part of the cost which exceeds that of an "ordinary" sleeping-berth shall be borne by the officer or member using it, unless in the case of an officer he holds a rank higher than that of Colonel.

(6) If a claim for a refund of the cost of a sleeping-berth on any journey is made, the travelling-allowance shall be reduced by one-quarter of one day's allowance for every such journey.

(7) Officers of higher rank than that of Colonel shall be entitled to deck-cabins in steamers and sleeping-berths on trains or motor-buses at the public expense. If members who are not of higher rank than that of Colonel use "special" accommodation, the cost over and above that of "ordinary" accommodation shall not be a charge against public funds.

(8) The provisions of this regulation shall apply only during service overseas.

#### COMPUTATION OF TRAVELLING-ALLOWANCE

26. (1) The travelling-allowance provided for in Regulation 25 hereof shall be for each day of twenty-four hours.

(2) The day shall be deemed to commence at the hour of departure from the member's place of duty.

(3) Where the absence is for one or more days of twenty-four hours and part of a day, the rate for such part of a day as aforesaid shall be one twenty-fourth of the full daily rate for each hour's absence. A fraction of an hour if less than half an hour shall not be taken into account, but half an hour or more shall be reckoned as one hour.

(4) Where during the course of a journey a member enters a camp or other establishment where rations and quarters are available for that member, the time of entry shall be considered as the termination of the journey, and the time of departure therefrom as the commencement of a fresh journey.

#### PAYMENTS INCLUDED IN TRAVELLING-ALLOWANCE

27. Travelling-allowance shall be deemed to cover the cost of meals, accommodation, and the employment of porters to handle luggage.

#### MEMBERS LEAVING AND RETURNING TO STATION OR HEADQUARTERS WITHIN TWENTY-FOUR HOURS

28. (1) Subject to the provisions of this regulation, where any member, in the course of his duty, leaves and returns to his station or headquarters, as the case may be, within a period of twenty-four hours, or where he undertakes a journey of the kind referred to in subclause (4) of Regulation 26 hereof and the period of that journey is less than twenty-four hours, the actual and reasonable expenses only, not exceeding in any case the amount of the appropriate travelling-allowance as prescribed by Regulation 25 hereof, may be paid to the member.

(2) In any such case as aforesaid the following provisions shall apply:—

- (a) The cost of conveyance of personal luggage from or to a railway-station or wharf or other terminus, or from or to the home of the member, or from or to the hotel or boardinghouse at which he is staying, may be allowed, so long as car-hire is not charged for the same journey:
- (b) The cost of travel in a motor-vehicle shall be allowed only in cases where it is the cheapest or only mode of conveyance or is authorized by an officer not below the rank of Major-General:
- (c) In all cases the least costly means of conveyance shall be employed, and if public transport is available it shall be used.

(3) Every claim for travelling-expenses under this regulation shall be accompanied by a voucher indicating clearly the nature of the duty on which the claimant was travelling and furnishing full details relating to the date and time and place of arrival and departure. Every item of expenditure exceeding 5s. shall be supported by a receipt.

#### UNIFORM-OUTFIT GRANT

29. Uniform-outfit grants shall be payable in accordance with, and upon the conditions set out in, the following scale:—

#### ALLOWANCE FOR TROPICAL KIT

30. (1) When any member in receipt of a uniform-outfit grant as a member of a home-defence unit is detailed for a short term of duty in the Pacific islands, an allowance of £15 for tropical kit shall be made to the member, such allowance to be paid once only.

(2) When any member in receipt of a uniform-outfit grant under Regulation 29 hereof is stationed in the Pacific islands no additional allowance will be granted.

**UNIFORM-UPKEEP ALLOWANCE**

**31.** (1) Uniform-upkeep allowances shall be payable in accordance with the following scale :—

(2) Every member entitled to any such allowance as aforesaid who returns to New Zealand from overseas shall be entitled to the allowance at the overseas rate for a period of ninety days following the date of the member's disembarkation in New Zealand or for the period from that date up to and including the last day on which the member remains on the strength of the Second New Zealand Expeditionary Force, whichever period is the less :

Provided that nothing in this subclause shall apply to any member who returns to New Zealand for a definite period of overseas leave or for a course of instruction if the member re-embarks for active service on the expiry of the overseas leave or on the earliest day thereafter on which transport is available for the member's re-embarkation.

(3) Every officer who is a prisoner of war shall be credited with the allowance without interruption from the date of his being taken prisoner, and shall be charged with the value of clothing issued to him from Army stocks from that date.

**EXPENDITURE OF OUTFIT GRANT AND UPKEEP ALLOWANCE**

**32.** (1) Out of the outfit grant and upkeep allowance every officer, and every member of the New Zealand Army Nursing Service, shall provide and maintain all necessary clothing and personal equipment, except field-glasses, prismatic compass, and revolver.



(2) Out of the outfit grant and upkeep allowance every member of the Women's Army Auxiliary Corps (Overseas Section) shall provide and maintain such articles as may from time to time be determined by the Minister.

#### FREE ISSUES OF CLOTHING AND EQUIPMENT

33. (1) Every warrant officer, non-commissioned officer, and soldier shall receive a free issue of clothing and equipment.

(2) Every member of the Women's Army Auxiliary Corps (Overseas Section) shall receive a free issue of such articles as may from time to time be determined by the Minister.

#### REPLACEMENT OF CLOTHING AND EQUIPMENT

34. (1) If any member, not being an officer or a member of the New Zealand Army Nursing Service, loses or damages any portion of his clothing or personal equipment while on service and the loss or damage is proved to the satisfaction of his commanding officer to have taken place in the course of duty, free replacements may be made.

(2) Any officer on ceasing to be a prisoner of war may be paid a sum not exceeding £25 (sterling) for the loss of his kit.

#### MUFTI ALLOWANCE

35. (1) Subject to the provisions of this regulation, on the discharge of any member, whether within or beyond New Zealand, or on his being transferred to area pool and placed on indefinite leave without pay, or on his being transferred to the demobilized section of a Territorial Force Unit, a mufti allowance shall be paid to the member.

(2) Except as otherwise directed by the Minister from time to time, and subject to such terms and conditions relating to the allowance as the Minister may from time to time prescribe, the mufti allowance shall be at the following rates:—

Provided that where any article is missing from the kit handed in by any member, not being an officer or a member of the New Zealand Army Nursing Service, the mufti allowance payable to that member shall be reduced by an amount equivalent to one-half of the current full value of that article.

(3) Every officer, and every member of the New Zealand Army Nursing Service, on being struck off the strength of the Second New Zealand Expeditionary Force after service overseas shall be entitled to a mufti allowance under this regulation without being obliged to return any articles of clothing.

## DEPENDANTS' ALLOWANCES

36. (1) Subject to the provisions of this regulation, there may be paid to any person coming within any of the classes referred to in the following scale such sum by way of allowance (in these regulations referred to as a dependant's allowance) as the Minister may in his discretion determine, but not exceeding in any case the amount set out in that scale as the maximum amount applicable to the class to which that person belongs, namely :—

(2) Where an application for a dependant's allowance is made within six months after the date on which the dependant may be regarded as having qualified for a dependant's allowance under subclause (1) of this regulation, the allowance may be paid from that date. If application is not made within the said period of six months the commencing date of payment shall be determined by the Minister, and, pending such determination as aforesaid, payment may be made from the date on which application is received.

(3) Where any member in respect of whom a dependant's allowance is being paid is reported missing or is reported dead, the allowance shall continue to be paid for a period of three months immediately following the date on which notification of the casualty is sent to the nominated next-of-kin of the member or, in the case of a death occurring in New Zealand, for a period of three months immediately following the actual date of death.

(4) Where any member in respect of whom a dependant's allowance is being paid is reported missing and subsequently reported dead or, not having previously been reported as a prisoner of war, is reported died while a prisoner of war, the allowance shall continue to be paid for a period of three months immediately following the

date on which notification of the fact that the member is missing is sent to the next-of-kin or immediately following the actual date of death, whichever is the later date.

(5) The payments referred to in subclauses (3) and (4) of this regulation shall continue to be paid for such period of three months as aforesaid, notwithstanding the death or remarriage or change of circumstances of any dependant during that period.

(6) The Minister may in any case refuse to grant a dependant's allowance, and may cancel, suspend, reduce, increase, vary, or otherwise deal with any such allowance.

(7) Regulation 15 of the Expeditionary Force Emergency Regulations 1940\* is hereby revoked.

#### PART IV.—PAY AND ALLOWANCES GENERALLY

##### FORFEITURE OF PAY AND SUSPENSION OF DEPENDANTS' ALLOWANCES

37. (1) Unless the Minister otherwise directs, and subject to the exercise of any general powers conferred on the Minister by these regulations, during every day on which any member, whether serving beyond or within New Zealand, is absent on account of any of the casualties set out in column 1 hereunder, the dependant's allowance and the member's pay shall be dealt with in the manner set out hereunder in columns 2, 3, 4, and 5 respectively :—

When the period of absence exceeds twenty-four hours the number of days of absence shall be deemed to be the total number of hours of absence divided by twenty-four, any fraction over being counted as an additional day.

(3) Where a member is held under open arrest, payment of dependant's allowance, allotted pay, and unallotted pay shall not, unless otherwise directed by the Minister, be affected.

VALIDATING CERTAIN PAYMENTS

38. Wherever it is provided by these regulations that upon the happening of any event payment of allotted pay and the allowance prescribed by Regulation 37 hereof shall cease or be suspended wholly or partly, all payments made by the Director, Base Records, prior to the receipt by the Director of information that such event has happened shall be deemed to have been validly made.

PAY AND ALLOWANCES NOT TO BE SUBJECT TO TAX

39. No deduction for social security contribution or national security tax shall be made from the pay and allowances paid to any member or from any allowance paid to any person wholly or partly dependent on such member.

PAY AND ALLOWANCES NOT TO BE CHARGED

40. (1) No assignment or charge of the pay of any member or of any allowance payable in respect of any member shall have any force or effect, whether such pay or allowance is at the time of the assignment or charge already due or payable or not.

(2) Notwithstanding anything in subclause (1) of this regulation, the Minister may—

(a) Order a compulsory allotment of or deduction from military pay and dependants' allowances in respect of any debt due to the Crown, which is not in respect of the repayment of principal sums, or accept a voluntary allotment or assignment of any such pay and allowances in respect of any such debt as aforesaid :

(b) Delegate to the Army Secretary the power to accept any such voluntary allotment or assignment as aforesaid :

Provided that, before acceptance by the Army Secretary of any such voluntary allotment or assignment he shall be satisfied that the balance remaining unallotted or unassigned is sufficient for the living-expenses of the member and his family.

(3) Regulation 16 of the Expeditionary Force Emergency Regulations 1940\* is hereby revoked.

PAYMENTS NOT MADE UNDER THESE REGULATIONS ARE NOT  
INVALIDATED

41. Nothing in these regulations shall be deemed to prevent payments on account of pay or allowances or any other payments out of the War Expenses Account established by the War Expenses Act, 1939, which could have been paid if these regulations had not been made.
