## THE TROUT-FISHING (SOUTH CANTERBURY) REGULATIONS 1936, AMENDMENT NO. 5

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Fisheries Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

### REGULATIONS

- 1. These regulations may be cited as the Trout-fishing (South Canterbury) Regulations 1936, Amendment No. 5.
- 2. These regulations shall be read together with and form part of the Trout-fishing (South Canterbury) Regulations 1936\* (hereinafter referred to as the principal regulations).
- 3. These regulations shall come into force in the 1st day of October, 1945.
- 4. Regulation 6 of the principal regulations, as amended by the Trout-fishing (South Canterbury) Regulations 1936, Amendment No. 4, is revoked, and the following regulation substituted:—
- "6. No person shall in fishing for trout or other acclimatized fish in the said district use—
  - "(a) Any bare hook; or
  - "(b) Any wood grub (hu hu); or
  - "(c) Any bait other than artificial fly, natural minnow, artificial minnow, inaka, silvery, bully, creeper, or worm; or
  - "(d) Any wire whatever, either plain or twisted; or
  - "(e) Any gimp, or gut trace of a greater length than 3 ft. or of a thickness greater than the equivalent of 21 standard wire gauge."
- 5. Regulation 8 of the principal regulations is amended by revoking paragraph (a) thereof.

- 6. The principal regulations are amended by inserting, next after Regulation 8a thereof as inserted by Regulation 5 of the Troutfishing (South Canterbury) Regulations 1936, Amendment No. 2, the following additional regulation:—
- "8B. No person shall in fishing for trout or other acclimatized fish in the said district—
  - "(a) With minnow, use—

"(i) More than three sets of hooks; or

- "(ii) More than three hooks of greater size than No. 4 (old scale) in any one set:
- "(b) With spoon, use more than one set of four hooks of a size greater than that known as 4/0."
- 7. Regulation 13 of the principal regulations, as substituted by Regulation 3 of the Trout-fishing (South Canterbury) Regulations 1936, Amendment No. 3, is amended by revoking paragraph (a) thereof.
- 8. Regulation 14 of the principal regulations is revoked, and the following regulation substituted:—
- "14. No person shall use any torch or other light, or any spear or gaff, for the purpose of catching fish of any description, except trout lawfully caught with rod and line, in—
  - "(a) Lake Alexandrina:

"(b) Lake McGregor:

- "(c) The tributaries of Lake Alexandrina:
- "(d) The tributaries of Lake McGregor:

"(e) The Opihi River:

- "Provided that nothing contained in this regulation shall prevent any person from spearing flounders in the Milford Lagoon, seawards from a point opposite Milford Road, leading to the lagoon on the east side, and marked by a post painted white."
- 9. The principal regulations are amended by inserting, next after Regulation 15 thereof, the following additional regulation:—
- "15a. No person shall use in fishing any bait other than artificial fly, artificial minnow, or spoon in—
  - "(a) Lake Alexandrina:

"(b) Lake McGregor:

- "(c) The tributaries of Lake Alexandrina:
- "(d) The tributaries of Lake McGregor."
- 10. Regulation 4 of the Trout-fishing (South Canterbury) Regulations 1936, Amendment No. 4, is consequentially revoked.
