



**THE TRANSPORT LICENSING PASSENGER REGULATIONS
1936, AMENDMENT NO. 6**

ORDER IN COUNCIL

At the Government House at Wellington, this 18th day of
April, 1945

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Transport Licensing Act, 1931, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Transport Licensing Passenger Regulations 1936, Amendment No. 6.

2. These regulations shall be read together with and form part of the Transport Licensing Passenger Regulations 1936* (hereinafter called the principal regulations).

3. These regulations shall come into force on the day following notification in the *Gazette* of the making hereof.

4. Clause (3) of Regulation 5 of the principal regulations, as added by the Transport Licensing Passenger Regulations 1936, Amendment No. 5, is amended by inserting, next following the words "Every license", the following words: "except a license to carry on a taxicab service within the meaning of the Transport Licensing Act, 1931, as amended by the Transport Law Amendment Act, 1939".

5. Regulation 5 of the principal regulations is further amended by adding thereto the following clause:—

"(4) It shall be a condition of every license to carry on a taxicab service (whether inserted therein or not) that in computation of the number of passengers for the purpose of assessing fares—

"(a) A child under the age of four years in care of a person of the age of fifteen years or over shall not be counted:

"(b) Any other child under the age of fifteen years shall not be counted, except that every two children under the age of fifteen years and not in the care of a person of the age of fifteen years or over shall be counted as one passenger.

6. Regulation 19 of the principal regulations, as amended by Regulation 3 of the Transport Licensing Passenger Regulations 1936, Amendment No. 2,* is further amended by revoking the figures and words “£650 (six hundred and fifty pounds)” where used in clause (1) thereof, and substituting the figures and words “£725 (seven hundred and twenty-five pounds)”.

7. Regulation 22 of the principal regulations is amended by revoking clause (2) thereof, and substituting the following clauses:—

“(2) Every person is guilty of a breach of these regulations who—

“(a) Fails to comply with any condition, duty, or obligation imposed by the said Act for which no penalty is provided by the said Act; or

“(b) Fails to comply with any condition, duty, or obligation imposed in any license under these regulations; or

“(c) Being the servant or agent of a licensee, does or omits any matter or thing within the scope of his duties as such servant or agent whereby there is or may be or is likely to be a failure on the part of the licensee to comply with any condition, duty, or obligation expressly or by implication or operation of law imposed in or made part of any license under these regulations; or

“(d) Offends against these regulations, or fails to comply with these regulations, or causes or permits or suffers a breach of these regulations to be committed.

“(3) Every person guilty of a breach of these regulations shall be liable for such breach to a fine not exceeding £10 without prejudice to his liability to any other penalty to which he may be liable, whether upon summary conviction or otherwise, and without prejudice to any other consequence arising from the breach.”
