## THE UNIVERSITY BURSARIES REGULATIONS 1962, AMENDMENT NO. 2

At the Government House at Wellington this 22nd day of December 1964

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

1. These regulations may be cited as the University Bursaries Regulations 1962, Amendment No. 2, and shall be read together with and deemed part of the University Bursaries Regulations 1962\* (hereinafter referred to as the principal regulations).

2. Regulation 2 of the principal regulation is hereby amended by revoking the definition of the term "University", and substituting the

following definitions:

"Tuition fees', in relation to the holder of any bursary, means nine-tenths of the consolidated fee duly prescribed by the Council of a University for the course taken under the bursary:

- "'University' means, as the case may require, all or any of the following, namely, the University of Otago, the University of Canterbury, the University of Auckland, the Victoria University of Wellington, the Massey University of Manawatu, and the University of Waikato; and includes Lincoln College."
- 3. Regulation 5 of the principal regulations is hereby amended—

(a) By revoking the proviso to subclause (1):

- (b) By omitting from subclause (2) the words "not being a University National Scholarship".
- 4. Regulation 10 of the principal regulations is hereby amended by omitting from paragraph (a) of subclause (2) the words "(including annual University or College fee)".
- 5. Regulation 14 of the principal regulations is hereby amended by omitting the words "together with the annual University or College fee".

- 6. (1) Regulation 20 of the principal regulations is hereby amended by omitting from paragraph (c) of subclause (1) the words "and is proceeding in his next year of study with a full-time course", and substituting the words "or who, in his first year of University study, being a year of study at a University other than a University in New Zealand, has been credited with passes in his course which are, in the opinion of the Council of the University in New Zealand at which he is enrolled, equivalent to the passes first mentioned in this paragraph".
- (2) Regulation 20 of the principal regulations is hereby further amended by adding the following subclause:
- "(3) Notwithstanding anything to the contrary in this Part of these regulations, the Director may also award a Fees and Allowances Bursary to a person who, while qualifying for the award of a Higher School Certificate or a Higher School Certificate in Fine Arts, has been prevented from qualifying for entrance to a University in a year earlier than that in which he has been granted a Higher School Certificate or a Higher School Certificate in Fine Arts, as the case may be, by reason of the fact that it has been necessary for him to reside outside New Zealand during the time that his parents, though normally resident in New Zealand, have as part of the duties connected with their livelihood been required to reside temporarily outside New Zealand:

"Provided that the Director shall be satisfied that the candidate for a bursary under this subclause has attended an appropriate educational institution for an appropriate time and would have attained the qualification for entrance to a University in an earlier year had he continued his education in New Zealand."

- 7. Regulation 22 of the principal regulations is hereby amended—
- (a) By omitting from subclause (1) the words "together with the annual University or College fee":
- (b) By revoking the proviso to subclause (2).
- 8. Regulation 28 of the principal regulations is hereby amended by adding, as subclause (2), the following subclause:
- "(2) Without limiting the provisions of subclause (1) of this regulation, for the purposes of these regulations the following courses shall be deemed to be courses leading to a Master's degree:
  - "(a) The course at the Victoria University of Wellington for the degree of Bachelor of Science with Honours and the degree of Master of Science:
  - "(b) The course at the Victoria University of Wellington for the degree of Bachelor of Arts with Honours and the degree of Master of Arts:
  - "(c) The course at the Victoria University of Wellington for the degree of Bachelor of Commerce with Honours and the degree of Master of Commerce:
  - "(d) The course at the Victoria University of Wellington for the degree of Bachelor of Music with Honours and the degree of Master of Music:
  - "(e) Any similar combination of courses at any University which the Director may specify by notice to the Registrar of that University."

9. Regulation 29 of the principal regulations is hereby amended by omitting from subclause (1) the words "together with the annual University or College fee".

### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the principal regulations so as to provide—

(a) That the tuition fees payable under a fees bursary or a fees and allowances bursary shall be nine-tenths of the consolidated fee for the course taken under the bursary:

(b) That satisfactory University work overseas may be recognised as a qualification for a fees and allowances bursary:

(c) That in certain circumstances a fees and allowances bursary may be granted to a person who qualifies in the same year for University Entrance and also for Higher School Certificate or Higher School Certificate in Fine Arts:

(d) That the boarding allowance in respect of a fees and allowances bursary may be paid in the sixth year of the course for the degrees of Bachelor of Medicine and Bachelor of Surgery:

(e) That the Master's Bursary shall be payable in certain additional cases:
(f) That the term "University" shall include the Massey University of Manawatu and the University of Waikato.
