An Act to amend the Housing Corporation Act 1974

BE IT ENACTED by the Parliament of New Zealand as follows:

1 Short Title

This Act may be cited as the Housing Corporation Amendment Act 1991, and shall be read together with and deemed part of the Housing Corporation Act 1974 (hereinafter referred to as the principal Act).

12 Transitional provisions

- (1) On the commencement of this Act—
 - (a) The Director-General shall vacate office as Chairman of the Housing Corporation of New Zealand:
 - (b) Every member of the Housing Corporation of New Zealand holding office immediately before the commencement of this Act shall vacate office.
- (2) Neither the Director-General of the Housing Corporation of New Zealand as Chairman of the Corporation nor any member of the Corporation shall be entitled to compensation for loss of office as Chairman or as a member.
- (3) Nothing in this section prevents a person who vacates office under subsection (1)(b) of this section from being appointed under section 3 of the Housing Corporation Act 1974 (as amended by section 3 of this Act) as Chairperson or as a member of the Housing Corporation of New Zealand.
- (4) The persons first appointed as members of the Housing Corporation of New Zealand under section 3(2) of the Housing Corporation Act 1974 (as substituted by section 3 of this Act) shall be deemed to have taken office on the commencement of this Act.
- (5) The member first appointed as Chairperson of the Housing Corporation of New Zealand under section 3(2A) of the Housing Corporation of New Zealand Act 1974 (as substituted by section 3 of this Act) shall be deemed to have taken that office on the commencement of this Act.
