(FROM 1st JULY, 1900, TO 30th JUNE, 1901).

AUCKLAND INDUSTRIAL DISTRICT.

(31.) AUCKLAND TAILORESSES.

THIS agreement, made in pursuance of "The Industrial Conciliation and Arbitration Act, 1894," and amendments thereof, this 7th day of April, 1900, between Archibald Clark and Sons (Limited), George Henry Powley, H. H. Seabrook, John M. Morran, M. Jordan, the Wellington Woollen Manufacturing Company, F. S. Lumsden, A. Dearsley, the "employers," of the one part, and the Auckland Tailoresses' Industrial Union of Workers, at Auckland, New Zealand (hereinafter called "the union"), of the other part.

Whereas an industrial dispute has arisen within the meaning of "The Industrial Conciliation and Arbitration Act, 1894," and amendments, and such industrial dispute was referred for settlement to the manufacturers on the one part and the representatives of the union on the other part : And whereas terms of settlement were agreed upon between the parties and approved of, and such terms of settlement are as hereafter appears :

Now this agreement witnesseth :---

In addition to the logs marked "A" and "B" respectively, and now filed with the Clerk of Awards at the Supreme Court, Auckland, as well as the items marked respectively "A" to "G," the following further items have been agreed to by the Auckland manufacturers on the one part and the representatives of the Auckland Tailoresses' Union on the second part :—

1. Second-quality double-stitched tweeds, price to be 3s.

2. Riding-breeches, second quality, to be from $4\frac{1}{2}d$.

3. Cashmere Chesters, pockets and seams tacked, price to be 2s. 4. All garments not provided for in either log prices to be arranged by manager of factory and three of the workers employed therein.

5. Copies of logs to be placed in a conspicuous position in each factory or workroom.

6. The price per week for the first four months for apprentices to be in conformity with the Act passed in 1899.

This agreement shall be an industrial agreement within the meaning of the said Act. This agreement shall operate and take effect from the 7th day of April, 1900, and shall continue until the 7th day of April, 1902.
