(2105.) AUCKLAND MERCHANT SERVICE GUILD.—AGREEMENT.

This industrial agreement, made in pursuance of the Industrial Conciliation and Arbitration Act, 1908, this 15th day of April, 1910, between the Northern Steamship Company (Limited) Industrial Union of Employers, of the one part, and the Auckland Merchant Service Guild Industrial Union of Workers, of the other part.

1. The Northern Steamship Company (Limited), Auckland, shall pay each certificated officer employed in the undermentioned steamers, according to his rank on board, at the rates set against

the respective steamers.

- 2. Whenever and so long as the s.s. "Ngapuhi" is on any run outside of a line from Bream Head to Cape Colville, her certificated officers shall be paid at the rates fixed in above schedule for s.s. "Rarawa."
- 3. Whenever and so long as the s.s. "Claymore" is on a west-coast run, her certificated officers shall be paid at the rates fixed in above schedule for the s.s. "Rimu."
- 4. Whenever and so long as the s.s. "Waitangi" is on a west-coast run, her certificated officers shall be paid at the rates fixed in above schedule for the s.s. "Rimu."
- 5. Whenever and so long as the s.s. "Daphne" is employed in the Auckland-Coromandel run, her chief officer shall be paid at the rate fixed in above schedule for the s.s. "Waitangi."
- 6. The rates of pay of officers employed in any steamers owned or controlled by the Northern Steamship Company (Limited), Auck-

land, other than those set forth above shall be fixed by mutual

arrangement between the company and the officer concerned.

7. An officer, when called upon to sleep on board at night in charge of the ship at the home port, shall be entitled, whenever practicable, to have the following forenoon off duty. In ships where two officers are carried, they shall perform this duty alternately unless the officers concerned otherwise mutually arrange, and in ships where only one officer is carried he shall perform this duty alternately with a seaman.

8. When any ship is going to sea, or arriving in port from sea, consideration shall be had, in deciding what officer shall go on watch or remain on duty, to the work which has before such departure or arrival been performed by the officers, with a view to

avoiding the imposing of excessive hours upon any officer.

9. A chief officer, after twelve months' continuous service with the Northern Steamship Company (Limited), shall be entitled in each year to ten days' leave of absence on full pay at such time as

the company shall determine.

10. Nothing in this agreement contained shall be construed as imposing any obligation upon the Northern Steamship Company (Limited) to employ in any ship more officers than are required to be carried in such ship by the provisions of the Shipping and Seamen Act, 1908, or any amendments thereof.

11. The provisions of this agreement and the provisions and conditions contained in the schedule shall bind the Northern Steamship Company (Limited) in so far only as respects ships owned by them which trade within the limits of the Northern Industrial District, or which trade in some trade one of the terminal ports of which is within the limits of the said industrial district.

12. This agreement shall come into force on the 1st day of April, 1910, and shall continue in force until the 31st day of

March, 1911.
