

(2307.) AUCKLAND DAIRY EMPLOYEES.—ADDING PARTIES TO  
AWARD.

In the Court of Arbitration of New Zealand, Northern Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1908, and its amendments; and in the matter of an award made on the 13th day of October, 1910, in an industrial dispute between the Auckland Dairy Employees' Industrial Union of Workers and F. Attwood and the other employers therein named.

Monday, the 10th Day of April, 1911.

UPON the application of the above-named union, and upon hearing the representative of the said union and such of the persons herein-after named as appeared on the hearing of the said application, this Court doth order that the persons named in the schedule hereto be and they are hereby added as parties to the said award, subject to the following conditions:—

1. The said award shall not apply to any of the said persons who at any one time are retailing milk from not more than two cows.

2. The said award shall not apply to any worker who is a child or other member of his employer's family.

#### MEMORANDUM.

The Court has made an order adding parties to the award asked for by the union, but in doing so has imposed conditions that will safeguard the interests of persons in the position of those retailers whose cases were put before the Court on the hearing of the application. The persons now added as parties will not come under the operation of the award unless they retail at any one time milk from more than two cows, and in any case the award will not apply to any work done by their own children or other members of their own family.
