MEMORANDUM AS TO ADDING PARTIES TO THE NEW ZEALAND TYPO-GRAPHICAL AWARD (Book of Awards, Vol. xiii, p. 721).

The application to add parties to this award was opposed by Mr. Pirani at Palmerston North on behalf of the proprietors of certain country newspapers and jobbing offices. His main objection was that these employers had not been afforded an opportunity of being heard before the award was made. The same objection arises in every case where it is sought to add any employer as a party to an existing award, but, notwithstanding this, hundreds of employers have been added as parties to existing awards. We think, therefore, that the objection cannot be allowed to prevail in the present case, and, as the employers represented by Mr. Pirani appeared to be in exactly the same position as the country employers in other parts of the Dominion

who are bound by the award, an order must be made as asked for by the Association of Workers.

Mr. Pirani asked to have a case stated for the opinion of the Court of Appeal, but the application does not raise any question of law on which it is desirable to take the opinion of that Court. Dated this 17th day of March, 1913.
