

(2853.) CHRISTCHURCH DRIVERS. — ADDING PARTIES TO AND EXTENDING OPERATION OF AWARD TO TIMARU.

In the Court of Arbitration of New Zealand, Canterbury Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1908, and its amendments; and in the matter of an award made on the 18th day of October, 1912, in an industrial dispute between the Canterbury Motor-car, Horse-drivers, and Livery-stable Employees' Industrial Union of Workers and T. G. Allen and other employers.

Friday, the 20th day of June, 1913.

UPON reading the application by the above-named union to extend the operation of the said award and to add further parties thereto, and upon hearing the duly appointed representative of the said union and such of the parties proposed to be added as appeared, this Court doth order that the undermentioned persons, firms, and companies shall be and they are hereby added as parties to the said award as from the 30th day of June, 1913, subject to the modification that clause 4 (c) of the said award shall apply to grocers as well as to bakers. And this Court doth further order that the operation of the said award shall be and the same is hereby extended to the area lying within a radius of five miles from the Chief Post-office in the Town of Timaru.
