The following firms or companies are exempted from the operation of the said award, subject to the following conditions: They shall pay not less than the wages fixed by the said award for any work coming within the scope thereof, and shall pay overtime for any work done by any worker in excess of forty-four hours in any one week at the following rates—that is to say, time and a quarter for the first three hours, time and a half for the next four hours, and thereafter double time. They shall also pay the rates prescribed by the said award for any work done on Sundays or on any of the holidays mentioned in the said award. They are exempted from the operation of all the other provisions of the said award: The Colonial Ammunition Company, Auckland; Turnbull and Jones (Limited), Auckland; and the Union Steamship Company of New Zealand (Limited).

The following special provision shall apply to the Auckland Gas Company (Limited): When workers coming within the scope of the said award are employed by the said company in or about their workshops they may be employed for forty-seven hours without payment of overtime, provided that they shall not be employed for more than eight hours and a half in any one day or four

hours and a quarter on Saturday.
