

(3959.) NEW ZEALAND FEDERATED PLUMBERS AND GAS FITTERS (NORTHERN DISTRICT).—ADDING PARTIES TO AWARD AND SPECIAL PROVISIONS *RE* AUCKLAND GAS COMPANY, AUCKLAND CITY COUNCIL, AUCKLAND HARBOUR BOARD, AND THE COLONIAL SUGAR-REFINING COMPANY.

The following special provisions shall apply to the Auckland Gas Company (Limited):—

1. "Plumbing-work" as defined by the said award shall not be deemed to include the following:—

- (a.) The laying of gas-mains in any street or public place;
- (b.) The laying of gas-service pipes from the main to the meter;
- (c.) The fixing of any gas-meter.

2. The wages for all journeymen gasfitters in the employment of the said company shall be fixed at 1s. 5d. per hour irrespective of whether they may or may not be registered under the Plumbers Registration Act.

3. When workers coming within the scope of the said award are employed by the said company in or about their workshops they may be employed for forty-seven hours without payment of overtime, provided that they shall not be employed for more than eight hours and a half in any one day or four hours and a quarter on Saturday.

The following special provisions shall apply to the Auckland City Council:—

“ Plumbing-work ” as defined by the said award shall not be deemed to include the following:—

- (a.) The laying of water-mains in any street or public place;
- (b.) The laying of water-service pipes from the main to the building-line of an allotment;
- (c.) The fixing of any water-meter.

The following special provisions shall apply to the Auckland Harbour Board and to the Colonial Sugar-refining Company (Limited):—

1. They shall pay not less than the wages fixed by the said award for any work coming within the scope thereof, and shall pay overtime for any work done by any worker in excess of the hours prescribed by the award and at the rates prescribed by such award.

2. They shall also pay the rates prescribed by the said award for any work done on Sundays or on any of the holidays mentioned in the said award.

3. They are exempted from the operation of all the other provisions of the said award.

4. When workers coming within the scope of the said award are employed by the said parties in or about their workshops they may be employed for forty-seven hours without payment of overtime, provided that they shall not be employed for more than eight hours and a half in any one day or four hours and a quarter on Saturday.
