

NORTHERN (AUCKLAND) INDUSTRIAL DISTRICT.

(4072.) AUCKLAND DISTRICT CARPENTERS AND JOINERS.— ADDING PARTIES TO AWARD.

In the Court of Arbitration of New Zealand, Northern Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1908, and its amendments; and in the matter of an award, dated the 16th day of April, 1914, made in an industrial dispute between the Amalgamated Society of Carpenters and Joiners' (Auckland District) Industrial Union of Workers and the Auckland Builders and Contractors' Industrial Union of Employers.
