**(5247.) NORTHERN DISTRICT RATTAN AND WICKER WORKERS.—
 ORDER AMENDING AWARD.**

In the Court of Arbitration of New Zealand, Northern Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1908, and its amendments; and in the matter of the War Legislation and Statute Law Amendment Act, 1918; and in the matter of the Northern District Rattan and Wicker Workers' award dated the 23rd day of September, 1918, and recorded in Book of Awards, Vol. xix, p. 884.

UPON reading the application of the Auckland United Furniture Trades' Industrial Union of Workers filed herein on the 9th day of May, 1919, and upon hearing the duly appointed representatives of the said union and of the employers parties to the said award, and with the consent of the said employers, this Court, having regard to all the relevant considerations and being of opinion that it is just and equitable to amend the said award, doth hereby order that the said award shall be amended in manner following, that is to say—

1. Clause 2 of the said award shall be deleted, and the following clause substituted therefor:—

“2. The minimum wage to be paid to journeymen rattan and wicker workers shall be at the rate of 1s. 7d. per hour.”

2. This order shall operate and take effect as from the 30th day of June, 1919.
