

(5265.) NEW ZEALAND FEDERATED TAILORESSES AND OTHER CLOTHING TRADE EMPLOYEES.—ORDER ADDING PARTIES.

In the Court of Arbitration of New Zealand, Northern Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1908, and its amendments; and in the matter of an award dated the 20th day of June, 1919, made in an industrial dispute between the New Zealand Clothing-manufacturers' Industrial Association of Employers and the New Zealand Federated Tailoresses and other Clothing Trade Employers' Industrial Association of Workers.

Le Roy above named shall be exempt from all the provisions of the said award so long as they shall work their workers not longer than the hours prescribed in the said award, and so long as they shall pay to the workers employed by them not less than the rates of wages prescribed in the said award.

This order shall come into force and take effect as from the 23rd day of June, 1919.
