

(6282.) OTAGO AND SOUTHLAND INDUSTRIAL DISTRICT
TAILORESSES (DRESSMAKERS AND MILLINERS). — ORDER
AMENDING AWARD.

In the Court of Arbitration of New Zealand, Otago and Southland Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1908, and its amendments; and in the matter of the War Legislation and Statute Law Amendment Act, 1918; and in the matter of the Otago and Southland Industrial District Tailoresses (Dressmakers and Milliners) award dated the 12th day of March, 1920, and recorded in Book of Awards, Vol. xxi., p. 212.

UPON reading the application of the union party to the said award filed herein on the 30th day of September, 1920, and upon hearing the duly appointed representatives of the said union and of the employers parties to the said award, this Court, having regard to all the relevant considerations and being of opinion that it is just and equitable to amend the said award, and by virtue and in exercise of the powers conferred by the said Acts and of every other power in that behalf enabling it, doth hereby order that the said award shall be amended in manner following, that is to say—

1. Subclause (b) of clause 4 of the said award shall be deleted, and the following provisions substituted therefor:—

“(b.) The minimum rates of wages prescribed for apprentices and improvers shall be increased by a bonus of 5s. per week, and the minimum wage for journeywomen shall be increased by a bonus of 3s. per week; and such bonuses shall be paid unless and until the Court shall otherwise order.”

2. This order shall operate and take effect as from the 1st day of October, 1920.
