(6357.) HAWKE'S BAY PROVINCIAL DISTRICT PAINTERS AND DECORATORS.—ORDER AMENDING AWARD.

In the Court of Arbitration of New Zealand, Wellington Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1908, and its amendments; and in the matter of the War Legislation and Statute Law Amendment Act, 1918; and in the matter of the Hawke's Bay Provincial District Painters and Decorators' award dated the 30th day of April, 1918, and recorded in Book of Awards, Vol. xix, p. 434; and in the matter of an order amending the said award dated the 15th day of May, 1920, and recorded in Book of Awards, Vol. xxi, p. 514.

Upon reading the application of the union party to the said award filed herein on the 6th day of November, 1920, and upon hearing the duly appointed representatives of the said union and of the employers parties to the said award, this Court, having regard to all the relevant considerations and being of opinion that it is just and equitable to amend the said award, and by virtue and in exercise of the powers conferred by the said Acts and of every other power in that behalf enabling it, doth hereby order that the said award shall be amended in manner following, that is to say—

1. The said order dated the 15th day of May, 1920, is hereby

cancelled, and this order is substituted therefor.

2. Clause 1 of the said award shall be deleted, and the following

provisions substituted therefor:-

"1. (a.) All journeymen painters, paperhangers, glaziers, grainers, signwriters, decorators, and distemperers, and all other journeymen working at any branch of the trade, shall be paid not less than 2s. per hour.

"((b.)) The minimum rate above prescribed shall be increased by a bonus of  $3\frac{3}{4}$ d, per hour unless and until the Court shall other-

wise order."

3. Clause 4 of the said award shall be deleted, and the following

provisions substituted therefor:—

"4. All time worked beyond the time mentioned in clause 2 hereof shall be considered overtime, and shall be paid for at the following rates: Time and a half for the first three hours, and thereafter double time. Time worked between 6 a.m. and 8 a.m., provided no work has been done on that day before 6 a.m., shall be paid for at the rate of time and a half. Work done on Sundays, Christmas Day, Good Friday, or Labour Day shall be paid for at double-time rates. In computing rates of overtime the bonus hereinbefore mentioned shall not be taken into account."

4. Subclause (h) of clause 6 of the said award shall be deleted

and the following provisions substituted therefor:

"(h.) The wages to be paid to apprentices shall be as follows: For the first year, 15s. per week; for the second year, £1 per week; for the third year, £1 5s. per week; for the fourth year, £1 10s. per week; and for the fifth year, £1 15s. per week."

5. The following additional subclause shall be added to clause 6 of the said award:—

"(j).) The minimum wages prescribed for apprentices by subclause (h) of this award shall be increased by a bonus of 1s. per week unless and until the Court shall otherwise order."

6. This order shall operate and take effect as from the 1st day of November, 1920.
