

(7119.) NORTHERN, WELLINGTON, CANTERBURY, WESTLAND, AND OTAGO AND SOUTHLAND INDUSTRIAL DISTRICTS FEDERATED CLOTHING TRADE EMPLOYEES.—ORDER ADDING PARTIES TO AWARD.

Provided, however, that the parties J. McGrath and Co., and A. Thompson and Sons, above named, shall be exempt from all the provisions of the said award so long as they shall work their workers not longer than the hours prescribed in the said award, and so long as they shall pay to the workers employed by them not less than the rates of wages prescribed in the said award while engaged on work coming within the scope of the said award, and provided further that the provisions of the said award relating to clothing-oilers shall not apply to the said parties so long as the work of oiling is performed under the same conditions and in respect of the same class of garments and materials as at present.
