2. That clause 13 (a) of the said award be read in all respects as if the words "the Auckland Electric-power Board, the Auckland City

Corporation, and the Devonport Steam Ferry Company, Limited," were inserted after the words "Tramway authorities."

3. That the following subclauses be and they are hereby inserted after subclause 13 (c) of the said award:—

"(cc.) The provisions of this award shall not apply to any work done in any sash and door factory."

"(ccc.) Ship, yacht, and boat builders are exempted from the operation of this award in so far as relates to priming and puttying work upon all ships, yachts, and boats, irrespective of size, and also in regard to all painting-work upon boats or vessels up to 35 ft. in length."
