

(8160.) NORTHERN, TARANAKI, WELLINGTON, CANTERBURY, AND OTAGO AND SOUTHLAND INDUSTRIAL DISTRICTS TEA-ROOMS AND RESTAURANT EMPLOYEES.—STRIKING OUT PARTIES FROM AWARD.

In the Court of Arbitration of New Zealand, Wellington Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1908, and its amendments; and in the matter of Northern, Taranaki, Wellington, Canterbury, and Otago and Southland Industrial Districts Tea-rooms and Restaurant Employees' award, dated the 28th day of November, 1924, and recorded in Book of Awards, Vol. xxv, p. 1676.

In pursuance and exercise of the powers conferred by section 92 of the Industrial Conciliation and Arbitration Act, 1908, and for the purpose of remedying a defect in the Northern, Taranaki, Wellington, Canterbury, and Otago and Southland Industrial Districts Tea-rooms and Restaurant Employees' award, dated the 28th day of November, 1924, and recorded in Book of Awards, Vol. xxv, p. 1676, this Court, being of the opinion that it is just and equitable to amend the said award, doth hereby order as follows, that is to say:—
