

(10453.) WELLINGTON INDUSTRIAL DISTRICT ELECTRICAL WORKERS.—AMENDMENT OF APPRENTICESHIP ORDER.

In the Court of Arbitration of New Zealand, Wellington Industrial District.—In the matter of the Apprentices Act, 1923, and its amendments; and in the matter of the Wellington Industrial District Electrical Workers' Apprenticeship Order, dated the 20th day of August, 1924, and recorded in Book of Awards, Vol. XXV, p. 775.

Friday, the 28th day of April, 1933.

WHEREAS by section 5 (2) of the Apprentices Act, 1923, the Court is empowered to amend any order made under section 5 (1) of the said Act: And whereas the Apprenticeship Committee set up in connection with the electrical trade in that part of the Wellington Industrial District lying within a radius of twenty miles of the General Post Office in the City of Wellington has made application to the Court for an amendment of the Wellington Industrial District Electrical Workers' Apprenticeship Order, dated the 20th day of August, 1924, and recorded in Book of Awards, Vol. XXV, p. 775: Now, therefore, the Court, in pursuance and exercise of the powers vested in it by the said Act, doth hereby order as follows:—

1. That the said Apprenticeship Order, in so far as it relates to that part of the Wellington Industrial District lying within a radius of twenty miles of the General Post Office in the City of Wellington, shall be amended by incorporating therein the following provisions:—

*“ Provisions relating to Radio Work.*

“(1) Radio work shall consist of all work as laid down by the Electrical Wiremen's Registration Board of New Zealand for Electrical

Wiremen's Limited Registration, and the constructing, installing, assembling, and repairing of radio instruments as specified in clause 1 (a) of the Wellington Industrial District Electrical Workers' Award, dated the 17th day of September, 1932.

"(2) The term of apprenticeship shall be four years.

"(3) (a) The minimum rates of wages payable to apprentices employed on radio work shall be :—

"(b) The rate of remuneration provided for in clause (3) (a) shall be subject to the provisions of the General Order of the Court of the 29th May, 1931.

"(4) The proportion of the total number of apprentices to the total number of journeymen employed on radio work by any employer shall be not more than one to two or fraction of two. For the purposes of this clause an employer who himself works at radio work shall be entitled to count himself as a journeyman: Provided that an employer who elects to count himself as a journeyman under clause 7 (i) of the order dated the 10th day of December, 1926, amending the Wellington Industrial District Electrical Workers' Apprenticeship Order shall not also be entitled to do so under this clause."

2. That this order shall operate and take effect as from the day of the date hereof.
