(10679.) DUNEDIN THEATRICAL AND STAGE EMPLOYEES.— AGREEMENT UNDER LABOUR DISPUTES INVESTIGATION ACT, 1913.

This industrial agreement, made in pursuance of the Labour Disputes Investigation Act, 1913, this 17th day of September, 1934, between the Dunedin Stage Employees' Industrial Union of Workers (hereinafter called "the union") of the one part, and the Clem Dawe's Revue Co. (hereinafter called "the employers"), of the other part, whereby it is mutually agreed by and between the parties hereto as follows:—

- 1. That the terms, conditions, stipulations, and provisions contained and set out in the schedule hereto shall be binding upon the said parties, and they shall be deemed to be and are hereby declared to form part of this agreement.
- 2. The said parties hereto shall respectively do, observe, and perform every matter and thing by this agreement and by the said terms, conditions, stipulations, and provisions respectively required to be done, observed, and performed, and shall not do anything in contravention of this agreement, or the said terms, conditions, stipulations, and provisions, but shall in all respects abide by and perform the same.

SCHEDULE.

First mechanist: Permanent, £6 2s. 6d. per week. residentFirst mechanist: Touring £7 17s. 6d. per week. Local mechanist £4 per week of forty-eight hours. Local property man £4 per week of forty-eight hours. Local electrician £4 10s. per week of forty-eight hours. All other workers

Where less than nine performances are worked, at pro rata rates.

£3 3s. per week for nine performances.

All casual work to be paid for at the rate of 2s. 3d. per hour.

All other matters where not specifically provided for in the above shall be covered by the provisions of the Theatrical and Stage Employees award, Vol. XXVIII, p. 283.

The Clem Dawes Revue Co. accept full responsibility for the employment of all stage employees wherever they are putting on one of their productions.

Interpretation.

Any matter incidental to or arising out of the agreement shall be determined by a committee consisting of two (2) representatives appointed by each party to the agreement. In the event of no agreement being arrived at the matter shall be referred to Conciliation Commissioner for the district, whose decision shall be final.

Term of Agreement.

This agreement shall come into force on the 17th day of September, 1934, and shall continue in force until the 24th day of September, 1935.
