## MEMORANDUM.

The Court was asked to add the names of a number of dairy-factory companies to the list of parties. It appears that these companies own bowsers, which are kept principally for the convenience of suppliers of milk and cream, though petrol is sold to the general public. There are no regular bowser attendants, and the work of attending to the bowsers does not take up more than a small part of the time of any of the assistants. The Court was informed that it was not the intention of these companies to vend petrol outside the usual store or factory hours. On this understanding, the Court has decided not to add the companies concerned. An apparent exception has been made in the case of the Joll Dairy Co., Ltd., but that company is bound in respect of its workshop only.
