THE Court of Arbitration of New Zealand (hereinafter called "the Court"), having taken into consideration the matter of the above-mentioned dispute, and having heard the union by its representatives duly appointed, and having also heard such of the employers as were represented either in person or by their representatives duly appointed, and having also heard the witnesses called and examined and cross-examined by and on behalf of the said parties respectively, doth hereby order and award:—

That, as between the union and the members thereof and the employers and each and every of them, the terms, conditions, and provisions set out in the schedule hereto and of this award shall be binding upon the union and upon every member thereof and upon the employers and upon each and every of them, and that the said terms, conditions, and provisions shall be deemed to be and they are hereby incorporated in and declared to form part of this award; and, further, that the union and every member thereof and the employers and each and every of them shall respectively do, observe, and perform every matter and thing by this award and by the said terms, conditions, and provisions respectively required to be done, observed, and performed, and shall not do anything in contravention of this award or of the said terms, conditions, and provisions, but shall in all respects abide by and perform the same. And the Court doth hereby further award, order, and declare that any breach of the said terms, conditions, and

provisions set out in the schedule hereto shall constitute a breach of this award, and that a penalty as by law provided shall be payable by any party or person in respect thereof. And the Court doth further order that this award shall take effect as hereinafter provided, and shall continue in force until the 2nd day of November, 1937, and thereafter as provided by subsection (1) (d) of section 89 of the Industrial Conciliation and Arbitration Act, 1925.

SCHEDULE.

Hours of Work.

1. The hours of work shall be forty per week, to be worked on five and a half days from 9 a.m. to 5 p.m. on one day, 9 a.m. to 5.30 p.m. on four days, and 9 a.m. to 12 noon on the day of the statutory weekly half-holiday. One hour shall be allowed for dinner.

Wages.

2. The following shall be the minimum rates of wages:—
Technicians—

A Grade: A worker competent to complete the processing of all classes of vulcanite, thermoplastics, clasp-work, gold-work, and use of artificial stones, and engaged thereon, £6 per week.

B Grade: A worker competent to do all vulcanite work, simple gold-work, use of stones and/or whipla and vitallium work, and engaged thereon, £5 per week.

A worker with not less than five years' experience and who is not qualified according to the above grades may be employed during the term of this award at a rate of not less than £4 per week.

No worker shall have his or her present wage reduced by reason of the coming into operation of this award.

Female Workers.

3. The wages paid to female workers shall be three-fifths of those paid to male workers.

Casual Workers.

4. Workers employed for less than one week shall be deemed to be casual workers, and shall be paid 25 per cent. additional to the rates prescribed in clause 2 hereof.

Overtime.

5. For all work performed outside of and in excess of the hours in clause 1 hereof, the following rates shall apply:—

Time and a half for the first three hours, thereafter double time.

Holidays.

6. The following days shall be observed as holidays: New Year's Day and the day following, Good Friday, Easter Monday, Anniversary Day, Labour Day, Christmas Day, Boxing Day, Anzac Day, King's Birthday.

Work done on any of the above-mentioned days or on Sunday shall be paid for at double rates.

In addition to the above-mentioned days one week's annual holiday shall be allowed and paid for at the usual rates observed. Workers dismissed from or leaving the employment of an employer shall be paid the proportionate amount they are entitled to for the time worked in lieu of holidays.

Payment of Wages.

7. All wages, including overtime, shall be paid weekly, before the ordinary time of ceasing work on any day of the week, not later than Thursday.

Term of Engagement.

8. The engagement shall be weekly, and one week's notice shall be allowed and given on either side.

Right of Entry upon Premises.

9. The secretary or other authorized officer of the union of workers shall, with the consent of the employer (which consent shall not be unreasonably withheld) be entitled to enter at all reasonable times upon the premises or works and there interview any workers, but not so as to interfere unreasonably with the employer's business.

Workers to be Members of Union.

10. (a) It shall not be lawful for any employer bound by this award to employ or to continue to employ in the industry to which this award relates any adult person who is not for

the time being a member of an industrial union of workers bound by this award, or who is not for the time being a member of a trade-union which was registered as such before the 1st day of May, 1936, and which is bound by this award:

Provided, however, that any non-unionist may be continued in employment by an employer bound by this award during any time while there is no member of a union bound by this award who is available to perform the particular work required to be done and is ready and willing to undertake it.

(b) For the purposes of subclause (a) of this clause a person of the age of eighteen years or upwards and every other person who for the time being is in receipt of not less than the minimum rate of wages prescribed by this award for workers of the age of twenty-one years and upwards shall be deemed to be an adult.

(NOTE.—Attention is drawn to subsection (4) of section 18 of the Industrial Conciliation and Arbitration Amendment Act, 1936, which gives to workers the right to join the union.)

Under-rate Workers.

11. (a) Any worker who considers himself incapable of earning the minimum wage fixed by this award may be paid such lower wage as may from time to time be fixed, on the application of the worker after due notice to the union, by the local Inspector of Awards or such other person as the Court may from time to time appoint for that purpose; and such Inspector or other person in so fixing such wage shall have regard to the worker's capability, his past earnings, and such other circumstances as such Inspector or other person shall think fit to consider after hearing such evidence and argument as the union and such worker shall offer.

(b) Such permit shall be for such period, not exceeding six months, as such Inspector or other person shall determine, and after the expiration of such period shall continue in force until fourteen days' notice shall have been given to such worker by the secretary of the union requiring him to have his wage again fixed in manner prescribed by this clause: Provided that in the case of any person whose wage is so fixed by reason of old age or permanent disability it may be fixed for such longer period as such Inspector or other person shall think fit.

(c) Notwithstanding the foregoing, it shall be competent for a worker to agree in writing with the president or secretary of the union upon such wage without having the same so fixed.

(d) It shall be the duty of the union to give notice to the Inspector of Awards of every agreement made with a worker pursuant hereto.

(e) It shall be the duty of an employer, before employing a worker at such lower wage, to examine the permit or agreement by which such wage is fixed.

Disputes.

12. The essence of the award being that the work of the employers shall not on any account whatsoever be impeded, but shall always proceed as if no dispute has arisen, it is provided that if any dispute or difference shall arise between the parties bound by this award or any of them, as to any matter whatsoever arising out of or connected therewith and not dealt with in this award, every such dispute or difference shall be referred to a committee to be composed of two representatives of each side, together with an independent chairman to be mutually agreed upon, or, in default of agreement, to be appointed by the Conciliation Commissioner for the district. Either side shall have the right to appeal to the Court of Arbitration within fourteen days after such decision has been made known to the party desirous of appealing.

Scope of Award.

13. This award shall operate throughout the Wellington Industrial District.

Term of Award.

14. This award, in so far as it relates to wages, shall be deemed to have come into force on the 2nd day of November, 1936, and so far as all the other conditions of this award are concerned it shall come into force on the day of the date hereof; and this award shall continue in force until the 2nd day of November, 1937.
