THE Court of Arbitration of New Zealand (hereinafter called "the Court"), having taken into consideration the matter of the above-mentioned dispute, and having heard the union by its representatives duly appointed, and having also heard such of the employers as were represented either in person or by their representatives duly appointed, and having also heard the witnesses called and examined and cross-examined by and on behalf of the said parties respectively, doth hereby order and award:—

That, as between the union and the members thereof and the employers and each and every of them, the terms, conditions, and provisions set out in the schedule hereto and of this award shall be binding upon the union and upon every member thereof, and upon the employers and upon each and every of them, and that the said terms, conditions, and provisions shall be deemed to be and they are hereby incorporated in and declared to form part of this award; and, further, that the union and every member thereof and the employers and each and every of them shall respectively do, observe, and perform very matter and thing by this award and by the said terms, conditions, and provisions respectively required to be done, observed, and performed, and shall not do anything in contravention of this award or of the said terms, conditions, and

provisions, but shall in all respects abide by and perform the same. And the Court doth hereby further award, order, and declare that any breach of the said terms, conditions, and provisions set out in the schedule hereto shall constitute a breach of this award, and that a penalty as by law provided shall be payable by any party or person in respect thereof. And the Court doth further order that this award shall take effect from the 28th day of December, 1936, and shall continue in force until the 28th day of December, 1937, and thereafter as provided by subsection (1) (d) of section 89 of the Industrial Conciliation and Arbitration Act, 1925.

In witness whereof the seal of the Court of Arbitration hath hereto been affixed, and the Judge of the Court hath hereunto set his hand, this 22nd day of December, 1936.

SCHEDULE.

Hours of Work.

- 1. (a) Except where otherwise provided a week's work shall not exceed $42\frac{1}{2}$ hours.
- (b) If more than nine hours' work is done in any one day, any excess beyond those hours shall be paid for at overtime rates.
- (c) Except as hereinafter mentioned, any work other than necessary attendance to horses or motor-vehicles before 7 a.m. and after 5.30 p.m. on five days of the week and before 7 a.m. and after 12 noon on the day of the weekly half-holiday shall be paid for at overtime rates as hereinafter specified, whether or not the weekly limit shall have been exceeded.
- (d) Ordinarily one hour shall be allowed for a meal, but this time may be curtailed by mutual agreement.
- (e) No worker shall work more than five hours continuously without an interval for a meal.
- (f) The local body shall provide a time-book or time-sheet in which each driver shall enter daily the total hours for which he is entitled to be paid, and the overtime, if any. The local body shall have the time verified and the book or sheet initialled each pay period.
- (g) Where practicable, local bodies shall so arrange the hours of work as to enable drivers to work their ordinary weekly hours on the first five days of the week.

- (c) Drivers engaged carting sewerage or nightsoil shall be paid 2s. per day in addition to the wages herein prescribed.

Casual Drivers.

3. (a) To ascertain the ordinary hourly rate of wages for casual drivers, the weekly wage in respect of the class of vehicle concerned shall be divided by the number of hours constituting the ordinary week's work, thus ascertaining the hourly rate, and 15 per cent. shall be added thereto: Provided that this clause shall not apply to regular employees temporarily engaged in driving, and provided further that if the rate of wages for drivers is higher than that fixed for such other employment they shall be paid the difference between their ordinary employment and their rate of pay as drivers calculated on an hourly basis.

(b) Casual drivers shall receive a minimum of four

consecutive hours' pay.

(c) A worker shall be deemed to be a casual driver who is not employed continuously for one week.

Holidays.

4. (a) Local-body drivers shall receive and be paid for the following holidays: New Year's Day, Good Friday, Easter Monday, Labour Day, Sovereign's Birthday, Christmas Day, Boxing Day, and two other days to be mutually agreed upon. The local bodies shall notify the union concerned of the two days agreed on.

(b) When any holiday falls on a Sunday the following day

shall be observed.

(c) Any work done on any of the above holidays or on Sunday or Anzac Day shall be paid for at double-time rates; such payment shall be in addition to the payment provided

for in subclause (a) hereof.

(d) In addition to the above holidays workers covered by this award shall be granted a week's holiday on full pay during each year of service with the same employer: Provided that a worker leaving his employment or being dismissed at any time shall be entitled to a holiday or equivalent of pay proportionate to the time he has served.

Where practicable, such holiday shall be given in proximity

to the Christmas or Easter Holidays.

Overtime.

5. Overtime for all drivers shall be paid for at the rate of time and a half.

Emergency Work.

6. (a) Emergency work shall mean work necessitated by wind, rain, fire, snow, storms, floods, tides, and earthquakes, and requiring immediate attention to keep open or restore essential services and shall include opening lake outlets.

(b) In the case of such emergency work, and notwithstanding anything contained elsewhere in this award, the following

provisions shall apply:-

(i) Except on the holidays named in clause 4 (a), up to nine hours may be worked on any one day without payment of overtime and time and a half rates shall be paid beyond nine hours' work on such days.

(ii) On holidays provided in clause 4 (a), ordinary time (in addition to the holiday payment provided for in clause 4 (a)) shall be paid for the first nine hours and time and a half beyond the first nine hours.

Drivers' Duties.

7. It shall be part of the ordinary duty of a driver to assist when required in loading and unloading the employer's vehicle. An employer may employ a worker who is substantially engaged as a driver at work outside his ordinary duties for the purpose of filling in time, but in such case he shall be paid not less than the award or ruling rate for such work: Provided that for all the time in any week that he shall be doing drivers' work he shall be paid the proportionate amount at the driver's rate of pay, and if in any week he shall be doing drivers' work for more than 50 per cent. of his time he shall be paid the driver's rate for the whole of that week.

Payment of Wages.

8. Wages shall be paid regularly either weekly or fortnightly as may be arranged between the local body and the drivers concerned, but where agreement is reached through the union representative wages may be paid monthly.

Term of Engagement.

9. In the case of workers other than casual hands, a week's notice of dismissal or resignation shall be given by the employer or the worker. This shall not prevent the employment of a driver in any one week at other than his usual work, without terminating his engagement as a driver.

Country Work.

10. (a) "Country work" means work at which a worker is

required to sleep away from home.

(b) Any worker sent to country work shall be conveyed by his employer to and from such work, free of charge, or his travelling-expenses going to and returning from such work shall be paid by his employer, but once only during the continuance of the work, if such work is continuous and the worker is not in the meantime recalled by his employer.

(c) Time so occupied in travelling shall count as time worked

and shall be paid for at ordinary rates.

(d) Such workers employed upon country work shall be paid an additional sum of 4s. 6d. per working-day, but the employer may in lieu thereof provide them at his own expense with suitable board and lodgings; or, where the employer

provides satisfactory accommodation, 2s. 6d. shall be paid for food allowance for every working-day the workers are in camp. For the purposes of this clause "satisfactory accommodation" shall include provision for cooking, storage of food, and reasonable sanitary conveniences.

(e) Workers making use of such accommodation shall keep it clean. If they fail to do so, the employer may employ some other person to do the work and may deduct the cost of such work from any moneys due or accruing due to such workers.

(f) Notwithstanding anything contained herein, an employer may agree with any worker that in respect of any specified country work the hours of work shall be other than those hereinbefore prescribed: Provided, however, that all time worked outside or in excess of such prescribed hours shall be considered overtime and shall be paid for at the rate of 1d. an hour in addition to the ordinary rates.

Travelling-time.

11. In the event of a driver being required to park or garage his vehicle or implement at a place other than the particular yard depot to which he is attached, the employer shall do one or other of the following things:—

(a) Provide the driver with free transport to and from

such vehicle or implement;

(b) Reimburse the driver any additional cost incurred by him in travelling to and from his work on account of his vehicle or implement being parked or garaged away from the particular yard or depot to which he is attached. Further, any additional time occupied by the driver in travelling to and from his work, due to the above cause, shall be deemed to be part of his day's work, and shall count as time or overtime, as the case may be, except that half an hour in going and half an hour in returning shall not be counted as time worked.

Working in Wet.

12. A "wet place" shall mean a place where workers are standing in water 3 in. or more in depth, or where water other than rain-water is dripping on them; but if the employer shall provide the workers with overalls or watertight gum boots, or both, the place shall not be deemed to be a "wet place." Six hours shall constitute a day's work where workers are working in wet places within the meaning of this clause, or foul air, and shall be paid for as if the workers had worked eight hours.

Disputes.

13. The essence of this award being that the work of the employers shall not on any account whatsoever be impeded, but shall always proceed as if no dispute had arisen, it is provided that if any dispute or difference shall arise between the parties bound by this award, or any of them, as to any matter whatsoever arising out of or connected therewith and not dealt with in this award, every such dispute or difference shall be referred to a committee to be composed of two representatives of each side, together with an independent chairman to be mutually agreed upon, or, in default of agreement, to be appointed by the Conciliation Commissioner for the district. Either side shall have the right to appeal to the Court against a decision of any such committee upon giving to the other side written notice of such appeal within fourteen days after such decision has been made known to the party desirous of appealing.

Accidents.

14. A modern first-aid emergency case, fully equipped, shall be provided and maintained by the local bodies in a convenient and accessible place.

Special Provision for Power Boards.

15. Electric-power Boards shall be at liberty to make special arrangements with their drivers as to the hours of work when required to work in connection with breakdowns or special work: Provided that the hours shall not exceed 42½ per week, and in the case of these drivers overtime shall be paid only for any time worked in excess of the hours herein prescribed. Further, this award shall not apply to those employees of Power Boards who are substantially employed as electricians or linesmen and paid as such, but only to those employees who are engaged as drivers and are substantially employed in that capacity.

Workers to be Members of Union.

16. (a) It shall not be lawful for any employer bound by this award to employ or to continue to employ in any position or employment subject to this award any adult person who is not for the time being a member of an industrial union of workers bound by this award or who is not for the time being a member of a trade-union which was registered as such before the 1st day of May, 1936, and which is bound by this award:

Provided, however, that any non-unionist may be continued in any position or employment by an employer bound by this award during any time while there is no member of a union bound by this award who is available to perform the particular work required to be done and is ready and willing to undertake it.

- (b) For the purposes of subclause (a) of this clause a person of the age of eighteen years or upwards, and every other person who for the time being is in receipt of not less than the minimum rate of wages prescribed by this award for workers of the age of twenty-one years and upwards, shall be deemed to be an adult.
- (Note.—Attention is drawn to subsection (4) of section 18 of the Industrial Conciliation and Arbitration Amendment Act, 1936, which gives to workers the right to join the union.)
- (c) The secretary or other representative of the union shall be permitted to interview employees in working-hours, but so as not to interfere unreasonably with the operations of the local bodies concerned.
- (d) Local bodies shall supply, on request, at intervals of not less than three months, to the secretary of the local union, a list of all drivers employed.

Under-rate Workers.

- 17. (a) Any worker who considers himself incapable of earning the minimum wage fixed by this award may be paid such lower wage as may from time to time be fixed, on the application of the worker after due notice to the union, by the local Inspector of Awards or such other person as the Court may from time to time appoint for that purpose; and such Inspector or other person in so fixing such wage shall have regard to the worker's capability, his past earnings, and such other circumstances as such Inspector or other person shall think fit to consider after hearing such evidence and argument as the union and such worker shall offer.
- (b) Such permit shall be for such period, not exceeding six months, as such Inspector or other person shall determine, and after the expiration of such period shall continue in force until fourteen days' notice shall have been given to such worker by the secretary of the union requiring him to have his wage again fixed in manner prescribed by this clause: Provided that in the case of any person whose wage is so fixed by reason of old age or permanent disability it may be fixed for such longer period as such Inspector or other person shall think fit.
- (c) Notwithstanding the foregoing, it shall be competent for a worker to agree in writing with the president or secretary of the union upon such wage without having the same so fixed.

(d) It shall be the duty of the union to give notice to the Inspector of Awards of every agreement made with a worker pursuant hereto.

(e) It shall be the duty of an employer, before employing a worker at such lower wage, to examine the permit or agreement

by which such wage is fixed.

Scope of Award.

18. This award shall operate throughout the Northern, Taranaki, Wellington, Marlborough, Nelson, Westland, Canterbury, and Otago and Southland Industrial Districts.

Term of Award.

19. This award shall come into force on the 28th day of December, 1936, and shall continue in force until the 28th day of December, 1937.

In witness whereof the seal of the Court of Arbitration hath hereto been put and affixed, and the Judge of the Court hath hereunto set his hand, this 22nd day of December, 1936.

MEMORANDUM.

The main questions submitted to the Court included wages and hours of work. Mr. Prime dissents from the hours of work fixed and considers that the hours should be the same as those agreed to in the general drivers' dispute.

Mr. Monteith does not agree with the cutting-out of the 1d.

per hour previously granted to local-body workers.

The provisions of the amending Act of 1936 relating to hours of work render it necessary for the Court to make a slight alteration in the country-work clause as agreed on by the parties. A provision has accordingly been inserted describing the additional hours worked on country jobs as overtime and prescribing therefor an extra payment of 1d. per hour.

Mr. Monteith is not in agreement with the additional rate fixed for country work. His dissenting opinion is subjoined.

DISSENTING OPINION OF MR. MONTEITH.

I dissent from the new low level of overtime payment. These men have to work forty-two and a half hours and then receive a payment of 1d. per hour overtime.
