

TARANAKI COACH AND MOTOR-BODY WORKERS.—VARIATION  
OF INDUSTRIAL AGREEMENT.

THIS agreement, made in pursuance of the Industrial Conciliation and Arbitration Act, 1925, and its amendments, this 31st day of July, 1937, between the Taranaki Coach and Motor-body Workers' Industrial Union of Workers and the Farmers' Co-operative Organization Society of New Zealand, Limited, and others, witnesseth that the parties aforesaid agree that the industrial agreement entered into between the same aforesaid parties and dated 22nd day of March, 1937, be amended as follows—that is to say, that clause 2 of the said industrial agreement be deleted, and the following clause substituted therefor:—

“ 2. *Hours of Work.*—(a) Subject to the provisions of subclause (b) hereof, the hours of work shall be forty per week, and may be worked between the hours of 7.30 a.m. and 5 p.m. on five days of the week from Monday to Friday inclusive, eight hours to constitute a full day's work.

“ (b) In the districts of Inglewood and Waitara work may be permitted on Saturday as long as the ordinary half-holiday is observed on any day other than a Saturday, and such other day on which the ordinary half-holiday is observed in these

districts shall be deemed to be Saturday for the purposes of this agreement, and all references in this agreement to Saturday shall be read to apply to such other day as aforesaid."
