

**WELLINGTON STOCK AND STATION AGENTS' CLERICAL
EMPLOYEES.—SUPPLEMENTARY AGREEMENT.**

THIS industrial agreement, made in pursuance of the Industrial Conciliation and Arbitration Act, 1925, this 30th day of June, 1938, between the Wellington Stock and Station Agents' Clerical Employees' Trade-union (hereinafter referred to as "the trade-union") and the Wellington Stock and Station Agents' Clerical Workers' Industrial Union of Workers (hereinafter referred to as "the industrial union"), of the one part, and the employers whose names appear in the Schedule hereto (such employers being hereinafter referred to as "the said employers"), of the other part: Whereas on the 23rd day of November, 1936, the trade-union and certain employers made and entered into an industrial agreement in pursuance of the said Act and its amendments (a copy of which industrial agreement is hereto attached marked "A"*): And whereas other employers were subsequently added to such industrial agreement and all such employers are referred to herein as "the said employers": And whereas on the 23rd day of June, 1937, it was agreed between the trade-union and the said employers to vary the said industrial agreement, and such variation was carried into effect by an industrial agreement dated the 23rd day of June, 1937 (a copy whereof is hereto attached marked "B"†): And whereas by a concurrence dated the 13th day of September, 1937, the industrial union signified its concurrence with the said industrial agreement dated the 23rd day of November, 1936, and the said industrial agreement varying the same dated the 23rd day of June, 1937: And whereas by an industrial agreement dated the 21st day of May, 1938, and made between the trade-union and the industrial union, of the one part, and the said employers, of the other part (a copy whereof is hereto attached marked "C"‡), the said industrial agreements dated the 23rd day of November, 1936, and the 23rd day of June, 1937, were renewed for a term from the 21st day of May, 1938, until the 30th day of June, 1938: And whereas the trade-union and the industrial union and the said employers are all desirous of further renewing the said industrial agreement dated the 23rd day of November, 1936, and the said industrial agreement varying the same dated the 23rd day of June, 1937, now therefore it is hereby agreed and declared between all the parties hereto:—

1. That the said industrial agreements dated the 23rd day of November, 1936, and the 23rd day of June, 1937, are hereby renewed for a term from the 30th day of June, 1938, until the 30th day of September, 1938.

2. That the term of this present industrial agreement renewing the said previous industrial agreements shall be for the same term—namely, from the 30th day of June, 1938, until the 30th day of September, 1938.
