**TARANAKI STOCK AND STATION AGENTS' CLERICAL
WORKERS.—VARIATION OF INDUSTRIAL AGREEMENT**

THIS agreement, made this 30th day of September, 1943, between Newton King, Ltd.; the Farmers' Co-operative Organisation Society of New Zealand, Ltd.; Levin and Co., Ltd. (hereinafter called "the employers"), of the one part, and the Taranaki Stock and Station Agents' Clerical Workers' Industrial Union of Workers (hereinafter called "the union"), of the other part. Whereas by an agreement dated the 6th day of November, 1942 (recorded in 42 Book of Awards 1299), and made between the parties hereto and registered as an industrial agreement under the provisions of the Industrial Conciliation and Arbitration Act, 1925, and its amendments, the terms and conditions of the members of the union employed by the employers were defined: And whereas by the said agreement it was provided that the terms

and conditions of employment should remain in full force and effect for a period of one year from the 1st day of October, 1942: And whereas it has now been agreed between the parties hereto that the said agreement be amended by enlarging the time during which the same shall remain in force from the period of one year to a period of two years—that is to say, from the 1st day of October, 1942, down to the 1st day of October, 1944: Now this agreement witnesseth as follows:—

1. The parties hereto hereby agree that the said agreement of the 6th day of November, 1942, shall be amended by deleting clause 20 thereof, and substituting therefor the following:—

“ Term of Agreement

“ This agreement shall be deemed to have come into force as from the 1st day of October, 1942, and shall continue in force until the 1st day of October, 1944.”
