NEW ZEALAND COOKS AND STEWARDS (STEWARDS).— AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand, Wellington Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulation 1942; and in the matter of an application for amendment of the New Zealand Cooks and Stewards (Stewards) award, dated the 13th day of May, 1940, and recorded in 40 Book of Awards 552.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and upon application made by a party to the New Zealand Cooks and Stewards (Stewards) award, dated the 13th day of May, 1940, and recorded in 40 Book of Awards 552, this Court doth hereby order as follows:—

1. That the said award shall be amended by deleting subclause (a) of clause 10 (Shore Pay), and substituting therefor the following subclause:—

"(a) Stewards working by a vessel when off the ship's articles, and before the time set out for commencing work by the ship's articles of agreement, shall be paid the following rates for time worked:—

" 'Ordinary time' means between the hours of 8 a.m. and 12 noon and 1 p.m. and 5 p.m., Mondays to Fridays, both inclusive, and 8 a.m. to 12 noon on Saturdays.

"For work performed outside the foregoing hours time and a half rates shall be payable, except on Sundays and holidays, when double time rates shall be payable: Provided that where a worker is paid sea-pay on a Sunday or holiday time and a half rates only shall apply.

"When a steward is engaged to work by he shall be given a definite starting-time and shall be paid a minimum payment of two hours at the above rates."

2. That for the purpose of removing doubts as to the operation of the two general orders of the Court made under the Rates of Wages Emergency Regulations 1940, and dated the 9th August, 1940, and the 31st March, 1942, respectively, it is hereby declared that the amended rates of remuneration provided by this order shall be increased to the extent and in the manner set forth in the said two general orders of the Court.

3. That this order shall be deemed to have come into force on the 1st day of April, 1945.
